**THE SPECIAL PANEL** of the Extraordinary Chambers in the Courts of Cambodia,  
**BEING SEISED OF** “KHIEU Samphân’s Application for Disqualification of Six Appeal Judges Who Adjudicated in Case 002/01” (the “Application for Disqualification”)<sup>1</sup>, dated 31 October 2019;

**NOTING** that the the Co-Prosecutors and the Civil Party Lead Co-Lawyers each filed their respective responses to the Application for Disqualification on 25 November 2019;<sup>2</sup>

**NOTING** that the composition of the Special Panel to hear the Application for Disqualification was finalised on 17 December 2019;<sup>3</sup>

**NOTING** that a separate case file for the documents related to the Application for Disqualification was created and notified to the parties and the Special Panel on 13 January 2020;

**NOTING** that pursuant to Internal Rule 34(7), when a party files an application for disqualification of a judge, “[t]he Judge shall be entitled to present written submissions to the Chamber within 10 (ten) days of his or her receipt of the application, through its President”;

**CONSIDERING** that the Application for Disqualification concerns not only one judge of the Supreme Court Chamber, but six judges of the Chamber, including the President;

**THEREFORE, THE SPECIAL PANEL HEREBY:**


