I. PROCEDURAL HISTORY

- On 29 July 2014, former International Co-Investigating Judge Mark Harmon ("ICIJ Harmon") summoned Im Chaem to appear at the ECCC for an initial appearance on 8 August 2014.¹ The summons was served on her on 31 July 2014.²
- 2. She failed to appear without excuse at the ECCC on the date for which she had been summoned.
- 3. On 14 August 2014, ICIJ Harmon issued an arrest warrant against Im Chaem ("Warrant") for the sole purpose of bringing her before the court for an initial appearance.³ The Judicial Police have not executed the Warrant.
- 4. As a consequence, Im Chaem was charged by ICIJ Harmon *in absentia* on 3 March 2015. The decision of the Pre-Trial Chamber on the appeal filed by Im Chaem on 2 April 2015 against that decision is still outstanding. 5
- 5. On 18 December 2015, the CIJs publicly notified the parties of the conclusion of the judicial investigation against Im Chaem⁶ and confidentially informed the parties of their inclination to dismiss the charges against Im Chaem for lack of personal jurisdiction.⁷

II. DISCUSSION

- 6. The judicial investigation against Im Chaem is concluded. Although the final decision on the outcome will be made in the Closing Order, there is currently no need for Im Chaem to attend any hearing on the notification of charges.
- 7. The Warrant is therefore moot and must be rescinded.

FOR THE FOREGOING REASONS, WE:

- 8. **RESCIND** the Warrant;
- 9. **ORDER** the Judicial Police to cease execution of the Warrant.
