#### RESPONSE

- 1. Pursuant to Internal Rules 55(2) and (3), the International Co-Prosecutor ("Co-Prosecutor") hereby responds to the International Co-Investigating Judge's Forwarding Order dated 6 February 2015.<sup>1</sup> This Forwarding Order transmitted the Case File to the Co-Prosecutors with a request for clarification as to whether the Toul Beng site falls within the scope of the judicial investigation, given that recent evidence shows that the site served as a security centre and was not only an "execution site", as alleged in the Second Supplementary Submission.<sup>2</sup>
- 2. The Co-Prosecutor confirms that the Toul Beng site falls within the scope of the judicial investigation.
- 3. The Co-Prosecutor remits the Case File to the Co-Investigating Judges for the continuation of the judicial investigation.
