- 1. Disagreements between the Co-Investigating Judges ("CIJs") in this case were registered on 7 February 2013, 22 February 2013, 17 July 2014, and 16 January 2017.
- 2. On 25 July 2017, the Ao An Defence filed in Case 004/2 a *Request for Clarification* in relation to the possibility of separate final submissions being filed by the Co-Prosecutors ("Request for Clarification").¹
- 3. On 5 September 2017, the CIJs issued their decision on the Request for Clarification ("Clarification Decision").²
- 4. On 28 August 2017, the Ao An Defence filed in Case 004/2 their *Urgent Request* for *Disclosure of Documents Relating to Disagreements* ("Request for Disagreements").³
- 5. On 18 September 2017, the CIJs issued their decision on the Request for Disagreements ("Decision on Request for Disagreements").⁴
- 6. The Clarification Decision and Decision on Request for Disagreements were also notified to the parties in Case 004 and placed onto Case File 004 as they informed the parties of the CIJs' views generally on disagreements between the Co-Prosecutors, the confidentiality of disagreements, the issuance of separate closing orders. Similarly, I consider the decisions will be of interest to the parties in Case 003 and they will thus be placed onto Case File 003.

FOR THE FOREGOING REASONS, I:

7. **ORDER** the Greffier to place confidential copies of the Clarification Decision and the Decision on Request for Disagreements onto Case File 003.

This decision is filed in English, with a Khmer translation to follow.
