THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia,

**BEING SEISED OF** the Appeals lodged by the National Co-Prosecutor<sup>1</sup> and the Co-Lawyers for AO An,<sup>2</sup> on 14 December 2018 and 19 December 2018, respectively, against the Closing Order (Indictment) delivered by the International Co-Investigating Judge on 16 August 2018 in Case 004/2,<sup>3</sup> and the Appeal lodged by the International Co-Prosecutor on 20 December 2018<sup>4</sup> against the Order Dismissing the Case against AO An (D359) delivered by the National Co-Investigating Judge on 16 August 2018 in Case 004/2<sup>5</sup>;

CONSIDERING that the briefing on appeal in this case is complete;

**NOTING** the submissions regarding the hearing, in response to the Pre-Trial Chamber's Notice of 7 May 2019,<sup>6</sup> filed by the International Co-Prosecutor<sup>7</sup> on 8 May 2019 and the National Co-Prosecutor<sup>8</sup> and the Co-Lawyers for AO An<sup>9</sup> on 9 May 2019;

PURSUANT to Internal Rules 77(3), 77(5) and 77(6);

**HEREBY ORDERS** that a hearing shall be held in the main courtroom on Wednesday, 19 June 2019, Thursday, 20 June 2019 and Friday, 21 June 2019 and **INFORMS** the Parties that the timetable for the hearing shall be as follows:

**ORDERS** that any dispense with personal appearance of the Charged Person for health reasons will require submission of a medical statement to the Chamber;

**DECIDES** that the hearing will be held in public until the report on the case is read in full by the bench and *in camera* thereafter.
