- 1. On 17 December 2021, the SCC declared that the case against Meas Muth was terminated. However, it did not itself formally order the case file to be sealed and archived.
- 2. Based on the SCC's decision, it only remains for us to formally seal and archive the case file, according to Internal Rule 69(2)(b) *mutatis mutandis* in the case of a termination order that is not strictly speaking a dismissal in the plain meaning of Internal Rule 67(3)(a).
- 3. FOR THESE REASONS, we¹ order Case File 003 to be sealed and archived.
