- C. Undertake all measurements, whether via GPS, photography or other hardcopy or digital means, needed to specify the geographic location of the site;
- D. Interview in accordance with the legal formalities any witnesses that could provide information relevant to the crimes under investigation. The Records of Witness Interview must be written in the language by the witness among the three official languages of the ECCC, where necessary, with the assistance of a sworn interpreter of the ECCC, and must be signed by the witness, the investigators and the interpreters having assisted in the interview.
- E. Examine any document conducive to establishing the truth;
- F. Report to us regularly on the progress of your work in carrying out this task.
