## I. PROCEDURAL HISTORY

- 1. Disagreements between the Co-Investigating Judges ("CIJs") in this case were registered on 22 February 2013, 5 April 2013, and 22 January 2015.
- 2. On 26 April 2016, I requested the Defence Support Section ("DSS") to organise a meeting with the Ao An Defence ("Defence") to devise a solution for the granting of the additional resources requested by the Defence on 15 March 2016.<sup>1</sup> I further requested DSS and the Defence to report to me on the outcome of the meeting.<sup>2</sup>
- 3. On 4 and 5 May 2016, respectively, the Defence and DSS filed their reports ("Reports").<sup>3</sup>

### II. DISCUSSION

- 4. Having considered the information in the Reports, I request DSS to provide the Defence, as soon as practicable, with the additional legal staff specified in the *Urgent Request for Additional Resources.*<sup>4</sup> The appointment of the requested additional legal staff will be initially until 30 September 2016, with the possibility of further extension should the needs of the investigation and the safeguarding of Ao An's rights so require.
- 5. This decision is filed in English, with a Khmer translation to follow.

### FOR THE FOREGOING REASONS, I:

- 6. **REQUEST** DSS to take all necessary steps to appoint, as soon as practicable, one Senior International Legal Consultant and one Junior International Legal Consultant to assist the Defence until 30 September 2016, with the possibility of further extensions should the needs of the investigation so require;
- 7. **REQUEST** DSS to inform the CIJs of the starting date of the two new consultants as soon as this information becomes available; and
- 8. **REMAIN SEISED** of the matter.
