DECISION ON INTERNATIONAL CO-PROSECUTOR'S REQUEST FOR INVESTIGATIVE ACTION TO PLACE SEXUAL OR GENDER-BASED VIOLENCE AND FORCED MARRIAGE DOCUMENTS ON CASE FILE 004

I. PROCEDURAL HISTORY

- 1. Disagreements between the Co-Investigating Judges ("CIJs") in this case were registered on 22 February 2013, 5 April 2013, 22 January 2015, and 21 October 2015.
- 2. On 24 April 2014, the International Co-Prosecutor ("ICP") filed a supplementary submission, requesting an investigation into allegations of forced marriage and sexual or gender-based violence in Case 004 ("Supplementary Submission"). ¹
- 3. On 14 March 2016, I charged Ao An with, *inter alia*, the crime against humanity of other inhuman acts; specifically, forced marriage and sexual violence in Kampong Siem and Prey Chhor Districts.²
- 4. On 9 December 2015, I charged Yim Tith with, *inter alia*, the crime against humanity of other inhumane acts; specifically forced marriage in Samlaut District in Sector 1 and Kampong Prieng and Reang Kesei Communes in Sector 4 of the Northwest Zone.³
- 5. On 9 May 2016, the ICP filed a request for investigative action to place sexual or gender-based violence and forced marriage documents in Case 004 ("Request").

II. SUBMISSIONS

- 6. The ICP requests that the CIJs place on Case File 004 10 documents and three videos from Case File 002 and one video available on YouTube ("Requested Materials"), which he submits are relevant to the allegations of sexual and gender-based violence and forced marriage.⁵
- 7. The ICP lists the Requested Materials and outlines their specific relevance in Annex A to the Request.⁶
- 8. While the ICP acknowledges there is some overlap with material already on Case File 004, the ICP submits the Requested Materials provide a clearer picture of the number of similar occurrences across the country, which is relevant to establishing a pattern and evidence of the physical and psychological impact of the crimes.⁷

III. DISCUSSION

A. Precision of the investigative action requested

9. The Request identifies the requested investigative action with sufficient precision; specifically, the Request identifies and describes each document and video to be placed onto Case File 004 in its annex.8

B. Prima facie relevance of documents and videos listed in Annex A

- 10. The Request provides sufficient reasons as to why the Requested Materials are relevant to Ao An and Yim Tith investigations into sexual or gender-based violence and forced marriage and conductive to ascertaining the truth.
- 11. The placement of the Requested Materials on the Case File will not delay the investigation, nor will it impinge upon the rights of charged persons in Case 004.

FOR THE FOREGOING REASONS, I:

- 12. **GRANT** the Request; and
- 13. **INSTRUCT** the OCIJ Greffier to place the documents and videos listed in Annex A to this decision on Case File 004.
