REQUEST

- Pursuant to Article 3.14 of the ECCC's Practice Direction on Filing of Documents¹ and Article 9.1 of the Practice Direction on Classification and Management of Case-Related Information,² the International Co-Prosecutor ("Co-Prosecutor") requests reclassification of *International Co-Prosecutor's Appeal of Closing Order (Reasons)*³ and *International Co-Prosecutor's Reply Regarding Appeal of Closing Order (Reasons)*.⁴
- 2. On 8 June 2018, the Pre-Trial Chamber ordered, *inter alia*, (i) the Co-Investigating Judges to issue a public version of the Closing Order (Reasons);⁵ (ii) the Co-Prosecutor to file a public version of his Final Submission;⁶ and (iii) Im Chaem to file a public version of her response to the Co-Prosecutor's Final Submission,⁷ each with redactions only as necessary to ensure the security of persons under protective measures or for whom the request for such measures was still pending. Additionally, the Pre-Trial Chamber reclassified as public the transcripts and audio/video of hearings dealing with the Co-Prosecutor's appeal of the Closing Order (Reasons), that were held *in camera* before the Pre-Trial Chamber on 11 and 12 December 2017.⁸
- 3. The content of the Co-Prosecutor's appellate submissions, as well as the documents underlying these submissions, are now in the public domain. Moreover, the interests of justice and transparency which led the Pre-Trial Chamber to order reclassification of the above documents,⁹ apply equally to the present request.

4. As such, the Co-Prosecutor requests that his Closing Order (Reasons) Appeal and Closing Order (Reasons) Reply be reclassified, with the same redactions as already set down by the Pre-Trial Chamber. This will promote the transparency of proceedings and ensure public access to the work of the ECCC to the fullest extent possible, consistent with the need to ensure the security and privacy of victims and witnesses. The Co-Prosecutor further submits that Im Chaem's response to the Co-Prosecutor's Closing Order (Reasons) Appeal should be reclassified for these same reasons. In the interests of judicial economy, the Co-Prosecutor suggests that this request be considered alongside Im Chaem's request for reclassification of various documents on the Case File.¹⁰
