THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia,

**RECALLING** its "Decision on the Pre-Trial Chamber's Reclassification of Documents in Case File 004/2", issued on 18 December 2019, in which the Pre-Trial Chamber decided that the Chamber will issue a decision on the reclassification of documents in Case File 004/2 after the issuance of its decision on the Appeals against the Closing Orders in Case 004/2;<sup>1</sup>

**NOTING** that the Chamber issued its public Considerations on the Appeals against the Closing Orders in Case 004/2 on 19 December 2019;<sup>2</sup>

**NOTING** that the Chamber remains seised of the Civil Party's Appeal against the Order on the Admissibility of Civil Party Applicants;<sup>3</sup>

**NOTING** that, pursuant Article 9(1) of the Practice Direction on the Classification and Management of Case-Related Information, documents can be re-classified and placed in a section of the case file with a different level of confidentiality only pursuant to an order of the Co-Investigating Judges or a Chamber, as appropriate;

### THEREFORE, THE PRE-TRIAL CHAMBER UNANIMOUSLY HEREBY:

ORDERS a Case File Officer of the Court Management Section to reclassify the documents listed in the attached Annexes I and II from "Confidential" / "Public Redacted" to "Public".
