I, PROCEDURAL HISTORY

- 1. On 16 August 2018, the International Co-Investigating Judge ("ICIJ") issued his Order on Admissibility of Civil Party Applicants in Case 004/2 ("Admissibility Order").
- 2. In a request dated 17 August 2018, four Civil Party Co-Lawyers requested an extension of time and increased page limit time to appeal the Admissibility Order, and for permission to submit their appeals in a single language with translations to follow ("First Request").²
- 3. In a submission filed on 21 August 2018, six additional Civil Party Co-Lawyers joined the First Request and asked for a longer extension of time to appeal the Admissibility Order ("Second Request").³

II. RESPONSE

4. The International Co-Prosecutor does not oppose the two requests given the complexity of the facts, the length of the ICIJ's Closing Order (over 400 pages), and the fact that translations of the Closing Order are currently still in progress.
