#### I. RESPONSE

- 1. On 28 June 2019, the International Co-Investigating Judge ("ICIJ") issued a closing order ("Indictment") indicting Yim Tith for genocide, crimes against humanity, war crimes, and violations of the 1956 Cambodian Penal Code, and committing him for trial. On 23 August 2019, the National Co-Prosecutor ("NCP") gave notice that she intends to appeal the Indictment. On 12 September 2019, she sought leave from the Pre-Trial Chamber to file her appeal in Khmer only, with the English translation to follow at the first opportunity.
- 2. The International Co-Prosecutor has no objection to the NCP's request to file in Khmer first with the translation to follow.
