- 3 QUESTIONING BY THE PRESIDENT:
- Good morning, Madam Civil Party. 4
- 5 Q. May we know your name?
- 6 MS. THOUCH PHANDARASAR:
- 7 A. [Interpreted from Khmer] My name is Thouch Phandarasar.
- 8 Q. Thank you, Madam Phandarasar.

Madam Civil Party, please observe a small pause before you speak. 10 You need to wait until you see the red light on the tip of the 11 microphone or the console so that your voice will go through the 12 system, in particular, through the interpretation system as your 13 voice will be interpreted simultaneously into English and French 14 and your microphone will be operated by the AV Unit.

- 15 How old are you?
- 16 MS. THOUCH PHANDARASAR:

[Interpreted from Khmer] Mr. President, I'd like to make a 17 18 request to Mr. President that I'd like to make my statement in 19 French as all my family members are living in France and they do 20 not speak Khmer and they are waiting to hear my statement in the 21 French language.

23 MR. PRESIDENT:

24 Please, do so. You can use any of the three languages used in 25 this courtroom. You can speak in French, of course.

- 4 Q. Can you tell us your age?
- 5 MS. THOUCH PHANDARASAR:
- 6 A. I was born on 22 August 1946. I am 67 years old and I am a
- 7 French citizen. And I'm married and I have three children, and
- 8 one of them died during the genocide.
- 9 Q. Where were you born and where is your current residence?
- 10 A. I was born in Phnom Penh in the third quarter and I was living
- 11 Tuek Thla with my parents. And currently I live in Paris.

- 13 MR. PRESIDENT:

14 Thank you, Madam Thouch Phandarasar.

15 As a civil party before this Court, you are given an opportunity 16 to make your statement of sufferings and harms occurred upon you 17 - namely, the physical, material and psychological impact - which 18 are the direct result of the crimes which led you to become a 19 civil party and which have been accused against the two Accused 20 here - that is, Nuon Chea and Khieu Samphan. And that they 21 occurred during the Democratic Kampuchea regime form the 17 April 22 1975 to the 6th of January 1979. And that is the opportunity that 23 we give you as a civil party in this case. You may proceed.

24 [09.17.25]

25 MS. THOUCH PHANDARASAR:

4

1 Yes, I remember 17 April 1975, when the Khmer Rouge entered the 2 city. We were all very, very happy to see a change in regime 3 because we were saying to ourselves that now there was peace; I saw my mother with her white flag smiling and she said: "That's 4 5 it, that's it, there's peace now. We're no longer going to suffer 6 from war and we're going to put - share our goods with the 7 community." And then we were all very enthusiastic; everyone was 8 joyful. Everyone was so joyful because the war seemed to be over 9 and during the afternoon, at the beginning of the afternoon, the Khmer Rouge soldiers arrived and they asked us to leave. We did 10 11 not understand why at the beginning.

12 [09.18.20]

We didn't understand what was going on; why, why we had to leave. We had to rebuild the country sharing our goods; we were willing to do all that was necessary for that and this Khmer Rouge soldier said to us: "We have to leave. You will only leave for three days because the government is trying to clean-up the city," he said. "So you have to leave so we can clean-up the city and to avoid the bombing."

And at the beginning, we were hesitant and then there were neighbours who told us that we have to get ready; there were people out in the street and I was with my parents. We were living in the same building, although we had each an apartment and my parents were also surprised. We were not ready to go and then after about an hour, other soldiers came and then we became

1	afraid because the soldiers were very aggressive and they asked
2	us right away to prepare our bags to leave for three days.
3	[09.20.08]
4	So my father, therefore, ordered us to collect our bags and to
5	prepare ourselves to go for a few days and I had two young
6	children with me and two nephews who are already in France, so -
7	but would come back - and there were four children and I tried to
8	gather a bit of clothing, some water and medicine. And then I
9	tied up the four children because there were too many people on
10	the way and I started becoming afraid because people were
11	everywhere. We had two cars and we couldn't proceed. We even had
12	to push the car at one point because there were so many, so many
13	people coming from everywhere and I - it was - my little sister
14	with a little bicycle next to me and she had arrived in the
15	evening. Of course, in the evening we arrived at the road to
16	Sihanoukville.
17	And then, suddenly, I heard a voice saying: "Give me your watch."
18	A very aggressive voice and since I was afraid of losing my
19	children whom I had tied together, then I heard a gunshot, and
20	then I saw a man who had just been killed and that is when I
21	understood that things were very, very serious. We were all very,
22	very afraid.
23	[09.22.29]

And then our cars were taken away from us. We also had a dog, a German shepherd. So they confiscated our cars, and my little

1 sister gave her bicycle right away to the Khmer Rouge, but the 2 dog didn't want to leave the car. And since we were so afraid, we 3 left all our clothes behind in the car. We only had water and rice to go to Kilometre 13, because at Kilometre 13 we had a 4 5 little plot and we had a little garden. And we arrived at 6 Kilometre 13 and we spent one night there. 7 The next day we kept on going with the soldiers forcing us to move ahead with the masses of people and then I saw the worst 8 thing of my life. I saw women give birth in the street and I saw 9 10 sick people in their beds with their drip on the road under the 11 burning sun and I saw people who couldn't walk. [09.24.11] 12 13 And children were forced to leave their parents behind and you 14 know that we worship our parents. Parents are very sacred to us 15 and when we saw parents separate from their children, it was 16 something that was extremely, extremely hard for Cambodian 17 children. So the soldiers forced us to move on and we spent two

18 to three nights in a village called Angk Romeas. And before we 19 entered the village, the - my grandmother's little nephews came 20 to collect us; they were in the village and they whispered to us, 21 there were three of them and they asked us to destroy of all our 22 administrative documents or I.D. cards so that we would have 23 nothing with us and they said that: "You have to change the name. 24 You're no longer called Darasar. Take a nickname." And it is as 25 of that moment that I have been called Tel, which is still the

3 So we remained in this village for a little while. In the morning we had to go out into the field to work. Some of the men would go 4 5 quite a ways away and come back every 10 days and the women were 6 working in the fields close by and every day there were spies 7 watching. And we stayed there for a few days, but it seemed so far to me and the nephews of my grandmother gave us food; gave us 8 9 rice and cassava. But there were no protein; there was no fish 10 for example - maybe a little bit of sugar which helped us a bit. 11 And then we had to evacuate this village; they asked us to board 12 trucks to Pursat province, first to Kampong Chhnang and then to 13 Pursat and then we took the train and this was a cattle train. We were packed together in these box cars and then we arrived in 14 15 Phnum Chonhcheang and it's at Phnum Chonhcheang that famine 16 really began; the true famine. So we had to build a shack. They 17 said: "Okay, sort it out." We didn't even have knives or forks or 18 - and we were obliged to bother to have knives so we could cut 19 branches to make these shacks, improvised shacks we could say. 20 [09.28.12]

And we started working very early in the morning and we would return very, very late at night. We only - and with very, very little food, only a little full of rice, and the children were very, very hungry. It was the rain season; we were very - we were soaked. And the children ended up in the mud without anything to

1	eat and they said, "Why are we coming - why - I want to go home,
2	where we had everything to eat. Why are we in the jungle? I'm
3	hungry." How can you answer that question? Young children, four
4	children.
5	And then the men would go plough the earth. And for the first
6	time I saw my father ploughing the oxcart - ploughing - pulling
7	the oxcart himself. I would see my father age by 10 years in a
8	few days, and this is something unbearable to see. I would see
9	his hair become grey; I would see him pull the plough in the mud.
10	So then I wanted to die. I could not stand this sight and I was
11	given work, as well when we were denounced.

13	So, the Khmer Rouge came then to collect us very early in the
14	morning. My husband was already ill and he was ill as of the
15	first days; his legs were swollen, so he stayed in the shack and
16	they brought us away; six families together. My grandparents have

1 myself, "That's it, they're going to shoot us here". But thank 2 God, they brought us to Boeng Kantuot and then at Boeng Kantuot 3 they questioned us for an entire morning and the group leader called Ta Khon (phonetic), who was with soldiers and women 4 5 soldiers, as well, and they asked us for our biography. Exactly 6 like what happened at the beginning; people were asking us about 7 our personal history. And we said, "Well, I'm a rice farmer". And we no longer had our documents, as I said. And, you know, we had 8 9 all been shopkeepers and it was very harsh questioning. They questioned us from early in the morning until late in the 10 11 afternoon, the same questions over and over again. You just said, "You're the wife of General Thach Sary. We were told that your 12 13 husband is a doctor, that - and that you-" But we always told the same story: that we are just simple people, ordinary people; 14 15 traders, shopkeepers.

16 [09.33.16]

17 And at one point, the wife of the general almost broke down. I 18 felt that she wanted to tell the truth, but finally, I shook her 19 up and she gathered her spirits and she remained calm and they 20 released us. It was about 1 o'clock in the afternoon and then 21 they gave us some food. That was fantastic; hard rice, real rice; 22 that was fantastic with dried fish. We really felt that that was 23 something that was extraordinary and I was so hungry. My parents 24 were jumping on the rice. I even heard rumours that we would 25 first be given food and then we would be killed and I was always

> 11 1 Ms. Feniès gave further testimony on the 9th of April 2009, and 2 the English ERN of that is 00852179 to 81; and in French, 3 00584551 to 53. Ms. Feniès has never been heard by the Prosecutor's Office nor by 4 the Co-Investigating Judges and she was met by the OCIJ office 5 under the heading of "Forced Transfer Stage 1". 6 7 [09.38.53] 8 Q. Now, Madam Feniès, to begin with, good morning. I have just mentioned the documents whereby you became a civil party. Now, 9 10 have you been able to re-read those documents since then and, if 11 you have, are they accurate or are there some points you might 12 like to give us further details on? 13 MS. THOUCH PHANDARASAR: 14 A. (Microphone not activated) 15 MR. PRESIDENT: 16 Please hold on; observe the light on the microphone when you 17 speak. 18 MS. THOUCH PHANDARASAR: 19 A. Yes, Counsel, I read the document and I did see that there was 20 a small typing mistake about the rocket that fell on my first 21 house in 1972. They weren't Khmer Rouge rockets; in fact, they 22 were Viet Cong rockets. In the documents it says: "Khmer Rouge 23 shells" and I'd like to have that rectified. 24 BY MS. GUIRAUD: 25 Thank you very much.

In the remaining time we have, Ms. Feniès, I'm going to be asking you some questions about the impact that everything you described may have had during your life, during the facts themselves and subsequently.

Q. In those opening remarks just now, you talked a great deal
about hunger. Was the deprivation of food that you suffered
something that had a serious impact on you afterwards and if so,

- 9 could you please tell us about that?
- 10 MS. THOUCH PHANDARASAR:

A. Yes. After that, after leaving Cambodia in 1979, I became a compulsive eater and I certainly put on a lot of weight. I always long for food. I can do without a great deal of things, comfort, money, whatever, even a roof over my head, but I need to have food.

Q. Thank you. In what you said this morning, you told us about your father and the elders and the importance of this in your culture. What are your feelings today about your parents? Does this still strike a particular cord with you today and, if so, tell us about it please?

22 sacred. You don't touch them and to see my parents dying well 23 before they were old, in their fifties, without me being able to 24 give back to them what they gave to me, is something that will 25 never be erased from my life.

2 The conditions in which they died were not worthy of animals. 3 It's better for animals; they get buried, but my parents died in a way that there are no words to describe; thrown into the ditch 4 5 naked. I didn't even know the place where he was discarded and I 6 retain a terrible feeling of guilt about this; not having been 7 able to save my parents. If I was perhaps a little braver I might have been able to feed them, bring them some rice or something. 8 You never erase memories like that and that's why I'm here to ask 9 10 this Court for justice. To give the deceased back their souls so 11 they may live in peace because, right now, I know their souls are 12 lost between the living and the dead and if there is justice that 13 would be an honour to them. That's why I want to come to Court for justice and not just for them; for the two million other 14 15 Cambodians who disappeared thanks to that Khmer Rouge regime. 16 [09.44.57]

18 Thank you, Ms. Feniès. You've told us about your parents and in 19 your opening remarks you also talked about one of your sons who 20 died during that period.

Mr. President, may I ask the Court's permission to put on the screens four photographs which will help me to ask some questions to Ms. Feniès about the members of her family who are in the photographs and about how she was able to keep the photographs? The photos were sent around to the parties yesterday. And now,

1 sir, I am asking you for your permission to project them on the 2 screens so as to be able to use them in questioning Ms. Feniès. 3 MR. PRESIDENT: 4 Thank you. You may proceed. 5 And I wish to remind the civil party that you have until 10 o'clock this morning to make your statement. 6 7 BY MS. GUIRAUD: 8 Thank you. 9 Q. Madam, you have the picture on your screen - I don't know if 10 everybody else does. And I'd like you to tell the Court and the 11 parties who the people in the photos are. [09.46.34] 12 13 MS. THOUCH PHANDARASAR: 14 A. He had meningitis. He took a biscuit from the mouth of a dog 15 that the Khmer Rouge had thrown away and then in the evening he 16 had a high temperature and his father who was a doctor, knew that 17 his son had meningitis. We tried to obtain some penicillin in 18 exchange for some jewels, but nobody had any and it was a very 19 hard day when he died. He had been wearing a T-shirt, a yellow 20 T-shirt and it had a slogan on the T-shirt, "If I smile to you, 21 do you smile to me?" And when he died, and I saw written upon his 22 chest: "Will you smile back to me?" while he was on his deathbed; 23 I think any mother would understand the appalling emotion I went 24 through.

2	you can tell us if you want to add something or if you would
3	rather not. I do want you to tell the Court and the parties about
4	how you managed to keep these photographs? We're looking at the

25	about the impact of crimes to understand what exile means; and

I'd like to ask you to describe to the Court and to the parties, the feelings that you went through when you reached France in 1979 with your son, who survived, and with your sister? A. I had three lives in a way. I had a fine life with my parents before the genocide and during the genocide it was sheer hell. Then after, in France, it was a struggle to survive, as well. [09.51.16]

I went through periods of terrible solitude because you had to 8 9 fight for everything; you had to go through your driving test again. You had to do evening classes to obtain the same degrees 10 11 and diplomas as before; you had to do menial jobs. It was a 12 complete uprooting. I know I had some French culture, but France 13 is an enormous place and I found myself in a world where the 14 transport, the seasons, winter was very difficult. There were 15 strikes; I had to feed a child and a sister and it was very hard 16 for me and I broke down. I went to a psychiatric institution for three months at one point. Psychologically, it was extremely 17 18 taxing.

19 Q. Thank you, Ms. Feniès.

20 Perhaps one more question before you ask the President if you can 21 put some questions to the Accused.

This morning you said you would like to speak in French because your new husband and your son and the members of your family do not speak Khmer, tell me, do you talk about that period now with your children?

I do understand your 24 great suffering, separating from your family members and you had 25 lost your loved ones. Nevertheless, the two questions you have

- 2 The first question was, of course, related to the second one. It

6 I am an intellectual. I was not an idealist (phonetic) of the 7 Communist Party of Kampuchea. And I would also like to inform you that the leaders - some leaders of the Democratic Kampuchea 8 9 Government, including some members of the Democratic Kampuchea 10 Government, considered me as a highly educated intellectual. They 11 considered my feet not attached to the ground, and I was 12 considered useless. I want to make this point precisely clear for 13 you.

Nevertheless, I forced myself to flee Phnom Penh. I took refuge in order to have the protection from the Communist Party of Kampuchea. I stayed with them for one year. And for two years, I had no choice but to join the Communist Party of Kampuchea. And subsequently, I gained some knowledge of their ideology gradually.

For these facts, I can only share with you what I had known.
According to the theory of the ideological principle of the
Communist Party of Kampuchea, revolution had to go through two
stages, the first one being the National Revolution - National
Democratic Revolution. This was the stage when we had to struggle
against the colonialism, the French colonialism and American

20

imperialism. And that was the period that National Forces had to be reunited to reconcile into a resistance force. Whether those people were former capitalists, they were still regarded for their reconciliation for the purpose of resisting and getting rid of the capitalism, which were considered the oppressed class on the peasant's class.

7 [10.02.10]

For that reason a lot of Phnom Penh residents at the time joined 8 9 in the Resistance Movement, and they joined the Movement in 10 various forms, including the process of demonstration and some 11 other activities opposing the Lon Nol regime, and sometimes they 12 collected the money together to buy the medicine for malaria 13 treatments to those who stayed in the jungle. At that time, 14 sympathizers to the Resistance Forces existed almost everywhere throughout Phnom Penh, and the majority of the sympathizers 15 16 resided in Phnom Penh. Although they might not assisted in 17 material support, they assisted in their sympathy and their 18 emotional support to the resistant movement. That was the first 19 phase.

20 As for the second phase, it was the Socialist Revolution phase 21 and the construction of <socialism>.

22 [10.03.42]

From my recollection, in April or in May, at the Silver Pagoda, that was the first time that a meeting was held by the Central Committee. Pol Pot, in his - representative of the Communist

21

1 Party of Kampuchea, made an announcement that the victory of the 2 17 April 1975 was indeed the end of the - of the Popular 3 Democratic Revolutionary Movement. It indicated that it's the conclusion of the United Front and of the GRUNK, and that 4 5 indicated the phase into the Socialist Revolution and the 6 Socialist Reconstruction and the protection of the country. 7 The idea behind Pol Pot's thinking was that the situation at the time was in need of an urgent attention. Vietnam, after <its 8 9 reunification>, they <needed> Cambodia, and for that they would 10 turn to attack us, so Cambodia had to urgently rebuild our 11 country and not to let <> Vietnam catch up and swallow us. So <> the Socialist Revolution and Reconstruction <were> of the 12 13 general concept that all the land <> no longer <belonged to> 14 members of the <cooperatives>; all the land became the property 15 of the cooperatives - that is, the property of the people. 16 Therefore, we build dams and canals in a speedier process so that 17 it <did not> have to have any conflict with any <> pieces of land 18 <belonging to this or that individual>, because the land was for 19 common use, and that would speed up the process of the 20 construction of dams and canals. 21 [10.06.46] 22 And I, myself, witnessed that in 1976. When I had the opportunity 23 to leave Phnom Penh, I saw canals and dams, including Trapeang

24 Thma dam, and the one to the west of Battambang, whose name I25 cannot recall; it was of huge size. As for the Trapeang Thma dam,

1 it looked like a sea in the middle of the field where there used 2 to be dry land. And as a result, those dry lands transformed into 3 chequered rice fields to the horizon, and that excited me. And, of course, the saying goes "Whenever there is rice, there is 4 5 everything". And the people would be fed sufficiently, and the 6 excess would be exported overseas, in particular to our friendly 7 countries, including China, Korea, Yugoslavia, etc., and that in return we would be able to purchase the agricultural products, 8 9 including hoes, knives, axes, etc., and we could even gradually build our factories with the imported iron, in order to build 10 11 water gates for the irrigational purposes for the rice fields. 12 [10.08.50] And I, indeed, saw the purchase of those large-scale machineries 13 14 that is to assist the people. But unluckily, those machineries

15 had not yet been distributed to the people due to the entering 16 into our territory by the Vietnamese forces.

17 And let me repeat again, I was excited when I saw those 18 large-scale dams. But during the course of the proceedings before 19 this Chamber, when I have heard the testimonies of the witnesses, 20 I was so shocked, as I was not aware that the dams, the canals 21 were constructed in exchange of such great loss. I did not know 22 that. And I was also extremely shocked whenever I heard the 23 testimony of any witness or civil party. And this is my words to 24 you.

25 Now, let me return to another issue. And it is because of that

23

understanding they tried to focus on all the forces of the country for the building of the dams and the canals. And, indeed, everyone who came here talked about building dams and canals. And the purpose at the time was not to split the forces inside the country, inside our nation.

7 As for the regime of criticism and self-criticism meetings, it was within the framework of the ideological principles of social 8 9 classes and class struggle, in particular for the Party's 10 members. During the popular revolutionary movement, the People's 11 Party had to sacrifice the most in order to be an example to the 12 entire nation, to the entire people, so that those people would 13 join in the Resistance Movement. And in order to form and achieve their due, criticism and self-criticism meetings had to form. 14 15 And everybody acknowledged that the Democratic of Kampuchea 16 forces were of the high merit. They were contradictory to the forces of the Khmer Serei, who only robbed the people of their 17 18 property.

As for me personally, I also had to participate in the criticism and self-criticism meetings in order to build myself into a proletariat class - that is, during the phase of the Socialist Construction. But I myself could not get rid of my former class because my mentality was still that of the capitalism and to the semi-capitalism, as I still had funds for my relatives and family

1	members. Of course, I tried to encourage myself to only focus on
2	the only benefit for the nation and that I should sacrifice
3	everything and concentrate my entire endeavour based on the view
4	of the proletarian class, of a poor peasant class and a poor

6 To start with, allow me to express my respect to all the souls of 7 the Cambodian people and to all the survivors who lost their relatives under the Democratic Kampuchea regime. Although during 8 9 that regime things were complicated, there were partisans within the country, and although they boasted themselves as Democratic 10 Kampuchea. But I myself, as one of the leaders, I acknowledge the 11 12 lack in this area. And, once again, allow me to express my regret 13 that the leadership was not of the perfect nature. That is the first instance. 14

They met the misery and the suffering, and I was shocked by that fact. 8 9 At the same time, I cannot forget the souls of the people and the male and female combatants who crawled under the bombardment of 10 the B-52 in order to liberate Phnom Penh. Those who died were 11 12 left where they were, and the ones who survived would crawl further to be near the lines of the Lon Nol soldiers in order to 13 14 avoid the bombardments from the B-52s. They joined the attack, 15 and several of them lost their lives. And I raise my hands to 16 pray and to express my respect with my humbleness to all those brave male and female combatants, as well as the souls of all 17 18 Cambodian people who died in the circumstances met by the nation 19 - that is, after the end of the American war, it led to the 20 Vietnamese war, and we never had any break of peaceful period 21 during the time. And, once again, I pray to the souls of all the 22 people.

31 1 English because it was from the United States Department of 2 Archives, the English ERN is 00168021. 3 [10.30.12] And in this document there is a heading talking about the French 4 5 Press Agency listing generals reportedly executed. It was a 6 broadcast through Hong Kong in English on the 21st of May 1976 7 and the text reads as follows - and I quote: 8 "Bangkok, 21st of May. The Khmer Rouge captured 54 Cambodian 9 generals when they seized Phnom Penh in April 1975 and reportedly 10 executed them, often with their families. The Cambodian 11 Resistance Movement claimed here today." 12 There is then a list of the 54 generals and I'd like to check 13 please, so that we're sure, the spelling on this is as follows 14 for General Thach, T-h-a-c-h, Sary, S-a-r-y. Is that the proper 15 spelling of your cousin, General Thach Sary's name? 16 [10.31.55]17 A. Yes, it is right, T-h-a-c-h S-a-r-y. He was in charge of 18 General Lon Nol's security detail. 19 Q. When the person informed you that your cousin, General Thach 20 Sary, had been executed, did that person mention any other people 21 being executed on that day who were connected with the Lon Nol 22 regime? 23 A. I don't know any further details, she told me those facts. We 24 held a brief ceremony, we prayed. And that's all I can tell you,

1 Q. I'd like to move on to a separate topic now, which is the time 2 when you've mentioned that you were on trucks going through 3 Kampong Chhnang to Pursat and you described them as cattle trains. Madam, we know that the evacuation of Phnom Penh was on 4 5 the 17 April 1975. Can you help me please, with how many months 6 later or what time of the year it was when you were on a cattle 7 train going through Pursat? [10.33.51] 8 9 A. Well, I must say the whole thing seems like an eternity, I 10 can't tell you how long it lasted, 3 months, 25 days; I'm not 11 sure. It was the train they used to deport us, we reached Kampong 12 Chhnang then Pursat and then they took us towards Phnum 13 Chonhcheang; these were the different phases. As for the 14 duration, time barely existed at the time, 20 days seemed like 2 15 months, 35 days could have been a year. A certain amount of time 16 went by, but that's all I can say. 17 Q. Did you have any choice whether to be on that cattle train or 18 not? 19 A. I had no choice whatsoever. We were constantly pushed by the 20 soldiers to get on to the train; the train was jammed packed with 21 people. 22 [10.35.07] 23 Q. Describe the period after you arrived as the time when the 24 true famine began. Can you help me, if you're able to, on how 25 long after you arrived in the forest or the jungle people first

2 A. When I was in Phnum Chonhcheang, there were already a good 3 deal of health problems, we had nothing to eat, some people tried to gather wild vegetables. I, myself, had a thorn in my thumb and 4 5 luckily my husband was able to operate on me because the whole 6 thing swelled up and I would have lost it if it had not been to 7 him. I had a high temperature and I wouldn't be here today if he hadn't solved that problem. And hunger had already become 8 9 widespread by that stage. They didn't give us anything to eat. 10 Q. This is my final question. You've arrived in the jungle. My 11 question is: Did people start dying within hours, within days, 12 within weeks or within months of that arrival in the jungle? 13 A. I saw people who had eaten too many wild plants who got 14 diarrhoea and began to die. But it was in 1976 that people 15 started to expire in large numbers.

Ms. Chan Socheat was admitted as a civil party after having filed her application in May 2010, on 10 September 2010 - so I am now going to allow the civil party to speak. She survived the entire Khmer Rouge regime; she was 18 years old in 1975 and she survived this tragedy and she will speak to you about it.

- 9 MR. PRESIDENT:
- 10 Civil Party, you may proceed.
- 11 MS. CHAN SOPHEAP:

12 Good morning, Mr. President. Good morning all the lawyers and

13 allow me to proceed.

On the 17 April 1975, I, as the rest of the Phnom Penh residents, were immediately forced to evacuate from Phnom Penh. I had 13 blood brothers and sisters, including my parents; there were 15 of us in total. So I had several younger siblings and the evacuation was very difficult for us.

The war was ended and I hoped that peace would come. But on the contrary, at around 9 a.m., Khmer Rouge soldiers with weapons entered our house and they told us to leave the house for three days as they needed to get rid of the enemy. At that time my parents had prepared our meal and we could not even eat the meal yet, and another group of soldier came to force us to leave

1 urgently as it is imminent that the Americans would drop bombs. 2 Upon hearing that we were all very scared, so we only could 3 manage to bring a bicycle and a motorbike to carry some belongings. And we did not even have the time to eat our rice and 4 5 we had to bring some hot water containers for the younger 6 siblings. En route the situation was even more difficult. When I 7 reached the Monivong Boulevard I was shocked to see the people en masse, I saw people with the drops (sic) on their hand, some died 8 9 along the road, some were crying for their children and family 10 members.

11 [11.19.59]

12 As for my family, we gathered everyone and we kept walking. We 13 crossed the Chbar Ampov Bridge and we stayed for three nights at 14 the pagoda there awaiting to return to Phnom Penh. But what they told us was a lie. We were not allowed to return to Phnom Penh 15 16 and we were forced to move further. My family then came to rest 17 at Kien Svay district and during the six-month period that we 18 stayed there, we experienced great hardship due to the lack of 19 food, the insufficient food and we did not bring enough food with 20 us. And the food that we were given was only rice and corn 21 grains, there was no meat or vegetables. So it was very hard 22 especially for my younger siblings and they lost their weight. 23 And the younger sister did not have any breast milk, so she only 24 could have the liquid gruel and later on she died. We did not 25 have any belongings with her, we only had small money and we

After the six-month period, the Angkar leader there made an 4 5 announcement that for those people who left Phnom Penh would be 6 allowed to return to Phnom Penh. My father was extremely happy 7 upon hearing that because he was an engineer and when the war ended, they would need the educated people to repair and to 8 9 rebuild the country. Although people whispered to us that it was 10 a lie, but in his mind he was determined to return to Phnom Penh 11 because of the poor living condition of the children. And if we 12 were to return to Phnom Penh, that would change. At 5 p.m., we 13 boarded a motorboat and there were hundreds of families on that 14 motorboat and we reached the river front in front of the Royal 15 Palace. And when we looked to the west we saw the light 16 reflecting from that direction and we were pretty happy to see 17 that scene, because we knew that now we arrived in Phnom Penh. 18 Everybody on the boat cheered. There was a man who was about 30 19 years old who shouted, "Bravo! Now we arrived in Phnom Penh!" 20 That person was called by the Khmer Rouge outside, and a moment 21 later we heard two shots being fired; that man fell into the 22 water. Upon seeing the situation, everybody became silent. Not 23 even the children - the children also became silent.

25 In very early morning, the boat arrived in Kampong Chhnang, and

1 we were distributed with three cans of rice. And each can was for 2 three people, and we were there awaiting to be - to board the 3 trucks to Pursat. That was at the junction of the Lieb river station. And then we stopped at Au Lieb in Moung Ruessei 4 5 district. The situation in my family, as the rest of other 6 families - in particular, for other families who had younger 7 siblings who could not walk - and we were still forced to travel on foot. And we went to live at Prey Totueng village. 8 The situation there was inhumane. There was nothing, no house. It 9 10 was just plain jungle, and to the south of the road there was an old rice barn. And there were three houses for the district 11 12 soldiers. Upon arrival there, we were instructed to clear the 13 forest and build our own house. And a meeting was held, and we 14 were instructed that, upon coming to live here - was of a 15 collective nature. 16 [11.25.31] 17 We would eat communally and we would work communally. I and my 18 elder sister were asked to work in the female unit, and my 19 younger siblings - some worked in the children's unit, and the 20 younger ones would stay behind with my parents. My father cleared 21 the land, ploughed the field, and planted some vegetables, 22 including pumpkins. We were asked to build dams and the ration 23 was five cubic meters per day. We were only given a ladle of 24 watery gruel. The situation was miserable. The food was

3 When I came home, the situation became even worse. All my younger siblings were emaciated or swollen, because the food there was 4 5 even worse than I was - with the female unit. Although over at 6 the female unit, I was given a ladle of watery gruel, but at the 7 house there was no (unintelligible) any rice; it was just ruined rice with a little bit of morning glory. We had to manage to eat 8 9 whatever we had, and we were not allowed to go and find anything 10 else to eat. As you could imagine, over there it was just a field 11 of jungle, and if we were to be caught then we would be treated 12 as an enemy. My siblings could not eat fully, and they could not 13 even sleep because of hunger. I was so pitiful on my younger siblings. They were so hungry, and if they could even have rice 14 15 with salt to eat, they would be very, very happy.

16 [11.28.08]

17 My parents and myself could not do anything for my younger 18 siblings but to sit and to shed our tears. Next morning, two of 19 my younger siblings died. We did not know what time they passed 20 away. And they continued to die, and my youngest daughter -21 sister - young - during a mealtime. Before she died, she begged 22 for just a piece of rice to eat. That is a tragedy under the 23 Khmer Rouge regime that I could not ever - I could not forget. We 24 were starved and we were given food like animals.

25 A fortnight later, my father died. In early morning, in fact, I

1	saw him sleeping. I went to wake him up. He opened his eyes and
2	asked me what time it was, and I looked at the sky and I told him
3	it's almost 7 a.m. He closed his eyes, and then he died. He died
4	in his sleep. I could not help him at all.

7	that my mother was unconscious, then they made a letter

17	sister. I was terrified. I saw my sister's physical look. She was

19	we did hard labour. Those who work very hard and met their quotas
20	- we were given only one or two watery - ladles of watery rice,
21	at that time. And just a few weeks, I got thinner. And if we
22	could not meet the quotas, we would be beaten. They were very
23	harsh on us. Seeing such great suffering, I decided to tell lies
24	to the unit chief - that our house had thread clothes, and these
25	could be made into a hammock. I told them, and they - in exchange

1	they gave us three cans of rice. And then next morning we left. I
2	actually persuaded my sister to leave with me.
3	My sister could - dare not leave with me, because she got used to
4	walking across the quiet jungle, in the forest, and she once
5	stepped on a landmine as well, and she was very frightened. And I
6	asked her - that there was nothing to be afraid of now. We had to
7	risk our lives, so that - we had to leave.

9	So with the three cans of rice, we left. When we walked across
10	the forest, we did not know where we were heading for. I did not
11	know where I should be going. I waited for three days for my
12	sister. I did not see her. I did not see her at all. I saw nobody

14	forest. So I waited in the forest, alone, for three days and
15	nights, and then I decided to walk toward the village.
16	When I got back to the village, I did not see my mother. My
17	mother was gone, and I decided to cook the three cans of rice I
18	had with me. I prepared - and then I got very sick at that time,
19	and I decided to go to a hospital - a place where people were
20	being treated - and to my surprise, when I got there, I saw my
21	mother. She was swollen - her body was swollen, and I - a few
22	days later, I decided to leave the hospital.

24	I did not go anywhere far from the hospital at that time, because

25 I had to know my mother's health status, because she was in

1	critical situation. I did not have anything to eat at that time.
2	What I could eat was the young pumpkins. I could still, at that
3	time. And I - the life was miserable and indescribable. I cooked
4	whatever I could get at that time for myself, simply to survive
5	for the day. And I thought that I could never survive at that

7	I changed the - I actually requested the unit chief over there,
8	that I had to travel to another place to meet my uncle. At that

17	rice pot and I saw rice over there, and Cambodian sour soup. And
18	I dropped my - I could not hold my tears at that time. I was
19	wondering why these people in this area could have something to
20	eat, while I had gone hungry for many days - or many months
21	already.

23	I saw the food, but I was so shocked that I could not actually
24	even eat it right away at that time. During the harvesting

sister - my sibling - falling down on the edge of the water. And her leg was swollen. I walked my sister to the hut, and my sister told me that one of my sisters had already died, because she had fallen from a house, and then her head was hit to a hole, and then she died. I was so sorrowful at that time. My siblings died one after another.

7 I had to be punctual when I had to harvest rice. One day, when I returned from my worksite to my hut, I was very shocked when 8 9 people told me that my sister had already died and they had 10 buried my dead sister. I was very shocked. I could not describe 11 it in words. This was really suffering. I tried to regain my spirit. I tried to work to satisfy them. But, of course, I only 12 13 had my physical strength, but my spirit was actually away. My soul was taken from me. 14

16 A few days later, some villagers who were sent to join me in 17 harvesting crops - they told me that my mother's health condition 18 was critical. I went to my unit chief telling him that I would 19 like to ask for leave to visit my sick mother. And then this 20 village chief actually blamed me, saying I was not a medical 21 doctor. I was not, so I was not allowed to go. And from that day 22 onward, I could never see my mother's face anymore. I was on 23 mobile - they sent me from one place to another to cultivate 24 crops. In 1977, the food regime was not sufficient. We - 10 of us 25 were given only three cans of rice. We only had a few ladles of

1	watery rice. And we ate communally. We did not have - actually,
2	pot - a rice cooking pot by ourselves. We only have one spoon
3	with us, and we were given only watery rice. And then we had to
4	drink water from the stream nearby - the contaminated stream
5	water.

7	For months, we would be allowed only one or two days to visit our
8	family. When I went to the village, to my terror, my mother was
9	dead. And this was the last time that all my members in the
10	family were killed. I was alone at that time. I was really
11	lonely, because all my siblings - my family members were all
12	killed, and they all died.
13	They actually punished us all day. We had to meet the quotas;
14	otherwise we would be accused of being the Vietnamese enemy. We
15	were considered feudalists. They contempted us. They threatened
16	to hit us with a hoe. So we had to work extremely hard at that
17	time, beyond any human capacity to handle the hard labour they
18	put down to us.
19	MR. PRESIDENT:
20	Thank you.
21	Counsel, you may proceed.
22	[11.41.16]
23	QUESTIONING BY MS. MARTINEAU:
24	Thank you, Mr. President.
25	Q. Madam, I think it's very painful for you to go through all of

1 these experiences again. You lost 15 members of your family. In 2 addition to your father, when you first arrived in Pursat, and 3 then your elder sister, a younger brother, another elder sister. And I can well understand that having to relive these experiences 4 5 is something violent for you. If you want, you can tell the 6 Chamber why you were there. Excuse me, why you are here. Why you 7 wanted to bring this complaint against the Khmer Rouge regime. If it's too traumatizing to talk about all of this, let's move to 8 9 some conclusions. And you will be asked some question, and in 10 that way you can say a little bit more about what attitude the Khmer Rouge leaders took to people like you as well. 11 MS. CHAN SOPHEAP: 12 A. May it please the Court and national and international 13 lawyers, I have one question I would like to put directly to the 14 15 Co-Accused. I have always wondered why the three years, eight 16 months, and 20 days was so cruel. Why did they do all of this 17 atrocity? I have endured tremendous suffering. It was so painful, 18 that I decided to file my application to join as a civil party. I 19 want the Court to seek justice for my family and for the 20 Cambodian families at large who have lost their loved ones. 21 [11.43.44] 22 I decided to file my application to join as a civil party. I am a 23 surviving witness who witnessed the atrocities by my own eyes. I 24 saw the suffering of Cambodian people. I hope that the testimony 25 - particularly my experience from the Democratic Kampuchea - will

2 I would like to request the Co-Accused to admit their guilt and
3 to apologize to those who died during the period, so that their

5 O. Madam, you talked to us about your children who were born 6 after 1980, and who fortunately never knew the regime. And often 7 they ask questions, you told me. And they say; "the entire family's dead, but you're alive". And you told me that it was 8 9 very hard to answer them. But I would like you to voice an answer 10 to that issue, because it's very important for us to know how you 11 survived. What resources you drew upon during the regime, and how 12 you explain to your children what actually happened.

14 A. Again, my respect to the Judges and everyone. I would like to 15 respond to your question. Of course, my children ask me the same 16 question. I had move from one place to another. I had to steal 20 something in order to eat. I did not have any sufficient food to 21 eat. I actually survived on stealing the young pumpkins or 22 watermelons to eat. And I witnessed a lot of suffering of other 23 people as well. When I was working on the rice fields, sometimes 24 I was asked and transferred to help the work site somewhere else. 25 And in the evening, on the way back to our place, we saw people

1 a.m. on the 17 April of the same year, some of my neighbours were 2 standing raising a white flag and so did our family. We shouted 3 that the war is now ended and the peace has returned. Some disabled people, old and young people, they were exhausted. 4 5 [14.04.38] 6 Young children were crying because of their - the feet pain and 7 along the road, I saw the corpses of Lon Nol soldiers dying and scattering. It was a pitiful situation. 8 9 When we got to Thnal Kaeng, we looked for a place to prepare our 10 food. We went out to collect water. Some of us were preparing for 11 our dinner. That was the first night. 12 I met very unfortunate things; the most unfortunate things in my life that I have never experienced. I - I slept on the road. 12	cage and I was covered with pig waste all over my body. This was
13	the suffering I had encountered. I was discriminated against
14	because I was accused of the 17 April People, and my physical
15	strength diminished by - day by day because I did not have
16	anything to eat.
17	[14.15.52]
18	As for my husband, he was assigned with a pair of ox and every
19	day when he came back home, he was very exhausted. He would lean
20	against the wall for a while before he went for a bath and had
21	dinner. At that time, I was very pitiful for my husband.
22	In 1978 he was not assigned to plough the field. He was assigned
23	to carry earth very far from home. My husband was a person from a
24	decent family in the city. He was not someone who could do that
25	hard labour job, but he was made to do it. He overworked and

77

because of this overwork; he suffered from a problem with his heart.

3 We had encountered these sufferings. We every day thought of our family members' living conditions. We were very desperate every 4 day and night of our family member, and we thought to ourselves, 5 6 why this regime inflicted torture against the people? Why didn't 7 they allow people to have sufficient food to eat, just rice to eat? Because we had harvested our crops and we know that the rice 8 9 yield was plentiful; people should have had enough food to eat. 10 [14.17.38]

And why didn't they provide sufficient medicine for the patient?
They only provide the "rabbit dung" medicine for them to - to
take whenever they're sick.

So, some of my family members were summoned to a meeting. They – they told us that they would go for training, for re-education, but then these people never returned home.

17 They killed the officials, the civil servants of the Lon Nol 18 administration, and we were questioning to ourselves why this 19 regime killed the former official. We wanted to know who the 20 leaders of this regime was and we - we wanted to know who the 21 leader was and what nationality they were; these were the 22 question we had in our minds all the time. Following the day of 23 work, I always thought to myself as to who led this organization; 24 who led this regime.

25 So, when the 17 of - the 7 of April 1979 arrived, I was very

1 happy. I thought that I would be able to look for my parents.

2 [14.19.00]

At that time, my second child was just born and I had to sell six chickens I had raised in order to have some pocket money to go and look for my family members. We packed our food. When I reached Stueng Slout, my heartbeat got faster and I thought to myself whether or not my family members had been killed during the regime and if that was the case and how would I stand this fact if I later discover it.

10 So I met my former village neighbours. I - he told me that I go 11 to this small hut. Actually, the - Niep (phonetic) told - came to 12 me and he hugged me and he told me that my mother and my five 13 siblings were executed during the regime. My mother was executed 14 on the accusation that she had in her possession a lot of gold, 15 and so they took her for execution.

16 Upon hearing this sad news, I was stunned. I could not say 17 anything and the next morning when I woke up, I wanted to die. I 18 really want to follow them, but I heard the crying of my small 19 baby, so I had to - I had to leave. I told myself that I had to 20 leave for my - for my innocent baby.

21 [14.21.07]

I would like to tell the Court that I am the fourth child in my family and I am only - the only survivor of whole family of the nine siblings. My grandparents, my parents, and other relatives; 22 of them altogether, die due to diseases, starvation, and other

2	As for my uncle by the name of Kok (phonetic), in Kien Svay, he		
3	was asked to do the work in the forest and he stepped on the		
4	landmine; he was killed, and his four kids were parentless -		
5	fatherless from that time onwards.		
6	And my other relatives were forced to work extremely hard and one		
7	day, he suffered from diarrhoea or cholera and then he died. He		
8	left behind six children to date.		
9	As for my brother, Huo Hanni (phonetic), he was the aviation		
10	soldier. Before 1975, he was dispatched to Thailand for training		
11	and following the appeal of Ieng Sary for the intellectual to		
12	return to the country to rebuild Cambodia, he decided to return.		
13	[14.22.46]		
14	And he did not have a chance to meet with his family member upon		
15	his return; he was arrested by the Khmer Rouge and he was later		
16	executed. He left behind many children.		
17	And my second brother, Huo Kim, before the 17 of April 1975, they		
18	live in Moan Chae market and then they were evacuated to Prey		
19	Veng province. My sister-in-law was four-month pregnant and their		
20	parent-in-law and other relatives were asked to stand in the		
21	queue and then they were killed with the hoe, one after another.		
22	When - my brother, who learned that his wife and relatives were		
23	killed, he grabs a knife to look for the murderers and then he		
24	was looking for the murderers. And then the people who killed his		
25	relative came out and then they were fighting with one another.

1 At that time my brother-in-law were killed by the Khmer Rouge and 2 eventually he died and he was gone forever. And my third brother 3 before the 17 of April 1975 he was a teacher in Phnom Penh. On the 17 of April 1975, his family was evacuated to Long Chen, 4 5 Takhmau. He was accused of possessing valuable belongings. He did 6 not agree to cede these belongings for communal use and then he 7 -his - the husband was taken away for execution. 8 [14.25.08] 9 And the wife of my brothers begged them for mercy. They begged 10 them not to kill her husband because they have four small 11 children behind, but they did not listen, they were merciless. They killed the husband and the wife; they died together; they 12 killed them. As for my mother, my mother was accused of 13 14 possessing valuable belonging - namely, gold - and she was 15 accused of not putting these valuable belongings for the 16 cooperative's use. My mother was taken to Kilometre Number 6 and she was detained and she was very hungry, she could not bear it 17 and then she decided to escape from the detention centre. And we 18 19 - she came to meet with her children and then the Khmer Rouge 20 soldier - people from the detention centre found them and they 21 arrested them and killed them instantly. Six of them were killed 22 in one instance. At the time, it was a horrifying experience; this was sorrowful and very, very horrifying. I cannot put this 23 24 in words. Who were the leaders of this regime? Why did they allow 25 Khmer to kill Khmer?

2 I was despaired. I find that I was useless; I had no family 3 members; my parents were all gone. I look at everything around me, everything was meaningless for me; my life is completely 4 5 meaningless. But I have my husband and two children who support 6 me every time. And soon after my husband suffered from a chronic 7 disease because of the hard work and his condition got worse and I send her to a doctor and then the doctor say that my husband 8 9 was suffering of a heart problem.

And at that time I got even more hopeless for my life, I became completely despaired. I did not want to live anymore and I have the wroth of this regime. My husband tried to teach, and I had to sew clothes and raise pigs in order to save money to send him for treatment. But then his situation never got better; he died in 1995. And then later I have three children.

16 I would like the Court and everyone to consider my situation, a 17 widow with five children. I have - my children did not have full 18 concentration on the study because they know our miserable

- 19 situation.
- 20 [14.29.29]

And we have endured all the sufferings. My family was in disarray because of this regime, never, ever a day had we had any happiness in the family. We never received any help from anyone; we did not receive the warmth of the family. It was so painful for me and I was so angry with that regime. And because of that

1 regime, my entire family was destroyed, and the misery remains 2 with my other five children and who became orphan till today. 3 Personally, I have had some psychiatric problem with hypertension as due to the shock, the terror repeatedly that I experienced 4 5 from that vicious regime. I tried to sew clothes, to raise 6 poultry in order to resolve our livelihood through such hardship. 7 I tried my best in order to be on my feet today and to be here today in order to find justice for my parents, my relatives, my 8 9 grand-parents, uncles and aunts. Today I am so excited that I am 10 given the opportunity by this International Court, who crossed 11 the oceans in order to come here to find justice for them and for the Cambodian people who died unjusticely (sic) under that 12 13 regime. Today this is the day that I have been waiting for more than 30 years with anxiety. 14

15 [14.31.34]

Today I would like to summon the spirit of my parents, my uncles, grand-uncles, aunts and all the relatives totalling in 22 who died under the regime, to be here with me in order to hear the prosecution by this Court of the murderers and to find justice for you all. And I know to be sure that they will be judged when they die.

My respect to the Court. I would like to make a request to you or Your Honours, which is the International Court, to judge fairly and justly in proportion to the gravity of the crimes that they have committed inhumanly against the nation and the people with

1 their torture and other cruel acts. The loss of lives unjustified 2 that happened to my family cannot be repaired. I would not 3 exchange just one life of my mother to a bucket of gold, let alone the 22 lives that were lost. The perpetrators and the 4 5 co-perpetrators who killed my family members shall be punished 6 severely and that they should be punished for the thousand years 7 of their lives and that they should not be reincarnated as human 8 being.

9 [14.33.23]

And I'd like to appeal to the true leaders of Democratic Kampuchea, you are now very old and this is the last - the final stage of your life. For that reason, you should be courageous to collect all your strength in order to shed light and tell the truths to all the victims and all the civil parties who are anxious to hear, to find justice and the truth and why your regime exterminate the people.

I would appeal repeatedly to all the organizations and institutions throughout the world, as well as the generous donors, to continue providing support to the civil parties who are the victims in proportion to their big loss in order to reconcile their mentality, their psychology and their physical and emotional beings. We are all of senior age and we are being haunted by all kinds of diseases.

Finally, in my representation of all the civil parties in Khsach Kandal district, Mukh Kampul district and Angk Snuol district, I

To me, that is 8 9 incorrect. As I stated already, they only needed the agricultural 10 land and products. For example, the land and the factory so that 11 they could be placed for common use in order to expedite the 12 building of the country. And that's what I heard of them speaking 13 in the meeting - that is in the meeting by the Central Committee. 14 But when it comes to the confiscation of personal belongings like 15 namely gold and diamonds, to me it's beyond my understanding. 16 Now, let's go to your second question. Allow me to tell you that 17 I did not have any big villa to live in. You can go and witness 18 it yourself in Pailin, how my wife and I lived. But this is just 19 a minor matter; at least it's for your information. 20 [14.42.41] 21 And because you said that being the leaders, why the leaders did 22 not know anything and why - and that we should be ashamed of the 23 younger generation. But I repeatedly tell you I did not know 24 anything about that. I was the Head of State but it was of a

25 nominal role, I did not have any executive authority. I only

1 represented an independent and sovereign Kampuchea, and that's 2 the limit of it. Let me touch on another issue that I was a member of the Central Committee. I was a candidate member until 3 late 1975 or early 1976 when I became the full fledge member. 4 5 Although in the Party Statutes it states that the Central 6 Committee was the supreme organization of the entire Party, in the actual practice - and allow me to make it clear to you and to 7 all the Cambodian people as well as to the Court - this is -8 9 existed only on paper. And also in the Party Statutes, it also 10 stated that the Central Committee only convened twice per year, 11 and that's the first point. And for the second point, for other 12 members of the Central Committee, they were responsible for 13 various bases, sectors and zones.

14 [14.44.52]

15 Only I, myself, was not responsible for any zone or sector, not 16 even a smallest unit of military. My role was to maintain good 17 liaison with Samdech and to distribute goods to zones and sectors 18 upon their request and based on the approval of the Standing 19 Committee. Therefore, it is clear that I could not know the 20 suffering and the misery as described by you. And you can put the 21 question that I participated in the Standing Committee's meeting. 22 I did participate in the meeting in my capacity as the Head of 23 State as I needed to liaise with friendly countries or the heads 24 of states. And for that reason, I needed to know some matters 25 concerning the development of the country. And for that reason, I

1 was asked to participate in that kind of meeting. And that kind 2 of meeting was a broad meeting for members like myself because 3 for certain meetings I was not allowed to know. And there were a lot of meetings that were held and I was not allowed to know. In 4 5 particular regarding the meetings concerning the arrests; and 6 this is for your information. And in my response to your question 7 that why I keep saying, "I do not know about this or do not know about that" - and that's for your consideration and for the 8 9 nation's consideration.

11 Now, on your third question regarding the class anger, allow me 12 to tell you I was also criticized during <each> Central 13 Committee's meeting, as I was asked to criticize and self-criticize in order to <build> my class stand <and class 14 15 anger> and that I should not maintain my capitalist stand that I 16 used to go and study in Paris. I told them, "I tried my best, but 17 it was the nature of my element." And as Nuon Chea stated this 18 morning, the education or the re-fashioning was for the elements, 19 not for the individual. I was not killed but they could not 20 refashion me when it comes to my element, because that was part 21 of me. And this is my response to you and I hope you understand 22 that, that I did not have the authority to make any decisions. 23 And whatever they wanted me to know, they would only allow me to 24 know to that limit and nothing else. And this is my response to 25 your questions.

And, lastly, please start your statement again. And you may state what you encountered, the hardship or the harms inflicted upon you during the Democratic Kampuchea regime, that is from 17 April 1975 to 6 January 1979. And you may state all your experience under the Democratic Kampuchea regime, and you may now proceed. MS. CHHENG ENG LY:

First of all, I am thankful to Mr. President and Your Honours for giving me this opportunity.

13 It has been over 30 years that I cannot forget what happened 14 under the Khmer Rouge regime; the mistreatment on more than 2 15 million Cambodian people, including myself.

16 On 17 April 1975, the situation and the cruelty at the time 17 cannot be described in words, and it was beyond anybody's 18 expectation. And they hacked away of a baby who was still 19 breastfeeding and that happened in front of me and it was 20 committed by the Khmer Rouge soldiers. How could you bear the 21 witness to such an event? While en route I saw a lot of people 22 who died along the road. I was leaving Phnom Penh along National 23 Road Number 1 and along the river I saw floating corpses, and 24 that shocked me.

25 [15.19.35]

93

1 I continued from Kien Svay crossing the river in an attempt to go 2 to Battambang province which was the native place of my parents, 3 but we could not reach the destination as my parents were sick and my siblings' bodies were swollen from malnutrition. We did 4 5 not have anything with us except the clothes that we wore. Two or three weeks after the 17 April 1975, money was still used 6 7 and we spent some money to buy something to eat, but later on it could not be used and we were placed in a cooperative. We lived 8 9 with the deprivation of food and we were only given a ration, and 10 the word "ration" there it means everybody would be given the 11 same thing and that only applied for the New People. And the New 12 People means the 17 April People who were from Phnom Penh and the 13 Old or the Base People were those who were living at their 14 villages. 15 [15.21.10] 16 We were given three ladles of watery gruel only with a few grains

17 of husked rice and a little bit of salt. I never want to recount 18 such an experience. The experience that we faced and that the New 19 People faced - and I can never forget that.

20 Our freedom was deprived. We were not allowed to cry, to love or 21 to speak. At 5 a.m. we were asked to work until noon and then we 22 were given three ladles of gruel. We worked again, and in late 23 evening we were given another three ladles, and then we worked 24 again until about 10.00 or 11.00. But I was not sure of the 25 hours, as we did not have any watch to look at.

94

1	And the work was hard. We worked during the night, and there was
2	no light. Sometimes we stumbled and fell down. We did not have
3	any shoes to wear and we only have one black clothes that we
4	wore.
5	And when we were sick, there was no medical treatment or medicine
6	provided, and if one was seriously ill that person will be given
7	a "rabbit drop" pellet. It could be a mixture of some rice and
8	some other stuff which was a bit sweet.
9	[15.23.02]
10	Could you imagine living without freedom? I carried a basket of
11	rice or corn on my head, and at that time I was about 21 years
12	old. And, of course, I was still at the age that I could still
13	grow taller but with such a weight on my body I could not grow
14	any taller, and that was the impact of carrying heavy things from
15	that regime.
16	I lived with a friend. I said a friend but that person was
17	someone else who left Phnom Penh. She said that she was thinking
18	of the two younger siblings, that she did not know where they
19	were. And just by saying that phrase, next morning - next early
20	morning - two black-clad soldiers came to us and called the two
21	of us to walk across the rice field. And when we reached a
22	location - but I cannot it - and they asked that person - her
23	name was Moi (phonetic) - to dig a pit of about her size. And
24	imagine that we did not have sufficient food to eat and she has
25	to dig the pit. And because of the exhaustion she could not

- 1 continue digging the pit. The two Khmer Rouge asked her whether 2 she already finished digging the pit, and then they pushed her 3 into the pit and buried her alive and they said that now we send 4 you to meet with your relatives.
- 5 [15.25.37]

I don't want to cry now, but when I recall it, it seems to be weaving in front of my eyes. She was buried alive, and the two soldiers said to me, "Now you see what happen. Now you return to work." I did not dare to cry. If I cry I would be killed by the two soldiers. I tried not to cry, then I came back to carry husked rice on my head again.

12 I tried to survive and tried to be humble to them. When I 13 returned to my workplace, I did not dare tell anyone there. I was 14 so shocked by seeing that friend buried alive.

15 Later on, I became unconscious and then I was pulled to the side 16 and they tried to massage me to wake me up. Upon gaining my 17 consciousness, I did not even dare to tell them what happened. 18 And when I was unconscious, a medic came with some kind of a 19 bottle of fluid. They were about to inject me. I gained 20 consciousness and I told the medic that it's okay, there is no 21 need for the injection. And, of course, I regained my 22 consciousness based on my mental strength. Every few days I kept 23 falling down because of the over-exhaustion.

24 [15.27.42]

25 Sometimes I thought of committing myself by jumping into the

96

river because we worked on the riverbank because I thought that living in the situation was meaningless. I could not even cry. I could not do anything. The food was insufficient. I did not have any strength. When I went up, or climb up a ladder, I had to climb up not only with my two feet but also with my two hands I was so weak.

7 My mother at the time was staying with me and if I were to die 8 nobody would look after her because for the porridge that was 9 given to me, I try to put either grass or morning glory mixed 10 with a bit of salt into it and I gave it to her. And because of 11 my mother, I decided not to commit suicide by jumping into the 12 river.

13 [15.29.06]

14 I, once again, cannot forget what happened under the Khmer Rouge 15 regime. I abandoned my study and, in fact, I determined to live 16 so that I could see what happened next and to see how far would 17 that Khmer Rouge regime went - rather, go.

18 What they did by killing millions of people were miserable. There 19 was no hygiene, no clothing, no medicine. Everybody got lice all 20 over the body and skin wounds.

I wish now to end my statement and I may respond to any questions that are put to me, but allow me to repeat that because of the living through the regime the result is terrible and it still remains with me. And the experience remains with me forever. I could not see anything that is bloody on the TV or on anything, I

Even with my husband, I cannot stand 8 9 if he speaks loudly because then it would give me a shock. And these are all the results of my experience living under the 10 11 regime.

A. I told the Court earlier that when we were leaving Phnom Penh and we were travelling along National Road Number 1 crossing Monivong Bridge, I saw a crying baby. He was actually crawling over the dead body of his mum. I wanted to carry that baby. I wanted to take the baby.

From the time when I wanted to carry the baby and the soldier 8 9 carried this baby was so brief that I could not actually do 10 anything. But all of a sudden when the soldier carried this baby, 11 they just tore the baby apart. It was a very horrifying scene. I 12 could not imagine any human being who would do that. This was 13 horrifying indeed. Actually, the baby was crying. He was crying because he was very hungry. He did not have any milk to drink. He 14 15 was crawling on the dead body. I did not want to take this baby 16 because I was also afraid of my own safety, so I did not say 17 anything, I just went on walking.

19 Q. Thank you for that answer. When you reached the cooperative, 20 what was the first thing you saw?

A. My apology, I could not really get the entire question you asked. You mean, when I first got to the cooperative or when I was working in the cooperative?

Q. No, when you first reached the cooperative and you saw these lines of people who apparently had rebelled. Could you tell us

They wanted to go back to Phnom Penh so that they would have enough food to eat and they would be able to use the bank note as they used to do.

10 So, at that time, a group of them was initiating the plot to 11 protest. There were around 20 or 20-plus of these men. Actually, 12 they did not use a rope but they used a thread. They actually 13 carried this - actually, they were frogmarched by the Khmer Rouge soldier later using only a small piece of thread tied up to their 14 15 hand. And then the Khmer Rouge soldiers threatened them, 16 threatened them with gunshot if they would ever protest. You 17 could imagine the situation back then. They only tied them up 18 with only a small piece of thread - string to their hand and they 19 frogmarched them out. I did not know where these people were 20 heading for, but I could only assume that they were all executed 21 afterwards. 22 And then when I reached Roka Kaong I noticed at that time that

there were four families who were gathered there. My family was one of them. And among these four families, there was one young boy, he disappeared. He was probably frogmarched with this group

1 of men as well and he never returned. 2 [15.38.03] 3 So we could not imagine anything, but we could only think to ourselves that these people would be killed then. 4 5 Q. Thank you for that answer. Can you tell the Court what the 6 impact of seeing that scene was on you? 7 A. When I saw them frogmarch these men out, I was horrified, and I thought to myself that something must have gone wrong and 8 9 nothing would ever return to normal. To put it simply, these 10 people would not be able to return to their place or they could 11 not return to the place where they came from. 12 And I also thought to myself that there would be execution and 13 the deprivation of freedom. They actually tied those men up 14 together with only a piece of thread, and this was a 15 manifestation of the dictatorship and the cruelty of this regime. 16 [15.40.28] 17 Q. Thank you very much. When you were in the cooperative you said 18 that the working conditions were deplorable. What sort of 19 relations did the head of your unit have with you? 20 A. Our living conditions at that time were described in three 21 categories; those who were in the senior age, middle age, and 22 youth or the younger age. I was in the middle age category at 23 that time. There were around 20 members of us with one unit 24 chief.

1 Q. Yes. But that unit chief, was he kind and considerate towards 2 you? A. No, no, he was not kind - she, rather, she was of a murderer 3 nature. She was cruel. She was aggressive. Whatever order she put 4 5 down was very harsh. She did not speak to us politely. Whenever 6 she addressed us she would accuse us of being the 17 April 7 People. She used vulgar language against us. It was not the tradition of Cambodia who address each other by this disgusting 8 9 language. We normally address each other politely, particularly 10 for Cambodian women. I consider the unit chief was a cruel person 11 - the words of the devil or the words of the ghost. 12 [15.42.48] Q. So, if I'm following you correctly, what you're saying is that 13 your membership of the New People earned you daily insults from 14 15 the unit chief; is that correct? 16 A. Yes, that is correct, that is correct. Every day we were 17 insulted. 18 Q. You also told us that one morning at dawn you were present at 19 the murder of your teacher friend who was buried alive before 20 your eyes. Can you tell the Court about the consequences of that 21 scene right up to the very day on you, yourself? 22 [15.43.55] A. Upon witnessing the burial of the friend, and I knew that she 23 24 did not commit any mistake - any serious wrongdoing at all. She 25 only said that she did not know the fate of her two siblings. So

1	I witnessed this lady being buried alive. And I had never seen -			
2	I had never seen at all, in the history of people - burying other			
3	people alive. Upon seeing this horrifying scene, I became			
4	exhausted, and I could not do anything. I witnessed that, but I

Q. My last question to you: Now, madam, you live in France and you've been living there for quite a few years. Can you tell the Court what the outcome and sequela of everything you went through during the Democratic Kampuchea regime?

7 A. Are you talking about the psychological or physical impacts? If you talk about impacts, of course I have a sustained 8 9 suffering. I have been affected both physically and 10 psychologically. - We just went along National Road Number 1. We reached Kbal Thnal,
   and then we crossed the bridge.

And then we went further until we ran out of any food reserves. We had with us some cash - some bank notes as well. And just a few weeks after that, bank notes could be used. We'd buy certain stuff for us to eat, as well. And we had some clothes with us - a few clothes with us that we could change along the way. And then I thought to myself that, if I continue to stay in Kien Svay, I would end up starving to death-

Q. I am sorry, Madam, I would like to interrupt you here. I just would like to make it clear, step by step. I would like to know the events that compelled you to leave your home. You said that black clad soldiers forcibly evacuated you from your home in Phnom Penh. Could you please tell the Court what the condition what the situation was like at that time, when they were forcing you out of your house?

A. When they got there - well, actually, I, at that time, was residing somewhere along - near Kilometre 6. They forced people to leave, and I had no choice but to leave my house. I reached my aunt's house, and then after that the soldiers forced us to leave our house. We had to comply. They told us at that time that if we did not leave our house, the American bombardment would be imminent. Then we had to leave. So we actually had heard of the
