Summary of Proceedings

Opening of proceedings and attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all parties were present except the national Lead Co-Lawyer during the morning session.

NUON Chea Defence request to follow proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Khieu SAMPHAN Defence Closing Statement Presentation

The Khieu SAMPHAN Defence started with raising the issues of the ECCC's legal legacy. Ms. Anta GUISSE submitted on the Proseuction's approach to criminal procedure, on charges including the treatment of the Khmer Krom, rape outside the context of marriage and deportation, as well as the Chamber's approach to evidence. Finally, she presented submissions regarding principles of law and legality.

Khieu SAMPHAN Defence Closing Statement Presentation on forced marriage

Mr. KONG Sam Onn submitted on the law applicable to forced marriage as a crime against humanity.

Khieu SAMPHAN Defence Closing Statement Presentation on armed conflict

Ms. Anta GUISSE addressed the armed conflict as a contextual element to examine facts and submitted on the factual and legal consequences of the armed conflict.

Khieu SAMPHAN Defence Closing Statement Presentation on crimes and crime sites Ms. Anta GUISSE addressed the crimes of murder, extermination, enslavement, imprisonment, persecution and torture at Krang Ta Chan.
