SUBJECT: Decision on Co-Prosecutors' Application for Extension of Page Limit Witness, Expert and Civil Party Internal Rule 87(4) Justifications

- The Trial Chamber is seised of a request by the Office of the Co-Prosecutors for the extension of the page limit applicable to their Internal Rule 87(4) submissions (E307/3). The Co-Prosecutors argue that as they are required to file reasoned submissions for the admission of all new individuals proposed after the June 2011 Initial Hearing (in accordance with E307/1), and as they have recently proposed 35 individuals not proposed before the beginning of Case 002 (E307), they will require more than the pages permitted by the Practice Direction on Filing of Documents Before the ECCC to attempt to justify the inclusion of these individuals. Accordingly, they request permission to submit a filing of 45 pages in English which encompasses all 35 individuals.
- The Trial Chamber grants the Co-Prosecutors' request, finding that the reasons they advance for an extension of the page limit represent exceptional circumstances. The Chamber considers that it is in the interests of justice, as well as the interests of procedural and logistical efficiency, for each party to file a single consolidated submission pursuant to Internal Rule 87(4) which encompasses all individuals who were not proposed at the beginning of Case 002. In view of the Civil Party Lead Co-Laywers' current proposal for the inclusion of 18 new individuals (E307/1.1), the Chamber requests them to submit a filing not exceeding 30 pages in English or French.
- This extension of the page limits applies only to Internal Rule 87(4) applications for the hearing of individuals not previously proposed at the beginning of Case 002. The Chamber invites the parties to file any application pursuant to Internal Rule 87(4) as soon as possible to facilitate the commencement of evidentiary hearings in Case 002/02.
