## Dear Mr Roberts,

Thanks for your letter of this past August 26th in which you informed me firstly that you have not received a copy of the letter from Mr Koppe dated this past April 21st with annexes. My apologies for this. Attached you will find the letter dated this past 21 April from Mr Koppe. The annexes are also included with the note that these annexes of course are already familiar to you from the case itself (annexes).

Secondly, you note in your letter of 26 August that I make no mention in my correspondence of the addendum of 19 February 2016 (E378/1). That would be because I am not aware of any such addendum. Until now I have based my investigation on the complaint submitted by you dated 11 December 2015 and thereafter, in so far as I can verify this, I did not receive any addendum from you.

Against this background, I would ask you to still - or once again - send me that addendum. After evaluating it I will see whether it is more practical to deal further with that addendum as a part of the complaint already being investigated or whether it would be preferable to start up a new investigation into the complaint or complaint elements included in that addendum, this also because the reaction of Mr Koppe to the complaint letter dated 11 December 2015 is already available and it is now up to you to react to it.

In any event, I will decide about this immediately after taking cognisance of the addendum and will then inform you of my decision.

From your letter of this past 26 August it is not clear whether Mr Koppe received a copy thereof. As is indicated in the national guidelines for handling complaints by the Dean that were sent to you earlier, it is a part of the investigation that the parties be informed of one another's position and the correspondence that is being exchanged about it within the framework of the investigation. Hence I am forwarding to Mr Koppe a copy of your letter of 26 August as well as a copy of this letter.
