SUBMISSION

- 1. On 2 May 2017, the Co-Prosecutors filed their Final Trial Brief together with a revised version of the OCIJ S-21 Prisoner List ("Revised OCIJ S-21 Prisoner List"). Through its review of translated and untranslated contemporaneous S-21 documentation, including entry and execution logs, biographies, confessions and photographs, the Revised OCIJ S-21 Prisoner List contained 18,133 individual entries.
- 2. Since filing the Revised OCIJ S-21 Prisoner List, the Co-Prosecutors conducted a final review of the entries in order to remove any remaining duplicates and ensure the most accurate list of individuals who entered and died at Tuol Sleng is before the Trial Chamber prior to its deliberations.
- 3. That review has led to the identification of 70 entries which the Co-Prosecutors consider are likely to be duplicate entries for the same individual. Of these, 10 originate in the OCIJ's original list and 60 in the additional entries added by the Co-Prosecutors to the list. The Co-Prosecutors understand that the OCIJ dedicated a significant amount of time and resources to preparing its list and thoroughly reviewed the records before concluding all of the entries thereon were separate individuals. However, upon further review and comparison, the Co-Prosecutors consider that the 10 entries identified are, in fact, duplicates. Of the 60 entries identified in the Co-Prosecutors additions as being duplicates most of these originate from S-21 prisoner photographs which the Co-Prosecutors now believe, upon further review and exercising an abundance of caution, to relate to individuals already included on the list by means of appearing in another form of contemporaneous record.³ The total number of individuals for whom existing contemporaneous records have been identified has therefore been corrected from 18,133 to 18,063.⁴

Where information in the entry now identified as a duplicate is not contained in the original entry on the list – that information has been incorporated into the original entry in Annex A in order to provide as much detail as possible for each individual on the list.

4. In addition to the Revised OCIJ S-21 Prisoner List, the Co-Prosecutors filed (i) a compilation of 60 figures and charts (Annex F2) and (ii) 57 annexes (Annexes F3 to F57) showing various breakdowns of the numbers and types of prisoners at S-21 at different times during the DK regime. A limited number of these figures, charts and annexes include entries from among the 70 duplicates. Where this has occurred, the impact on the analysis is less than 1% difference. The Co-Prosecutor's therefore do not consider it necessary to file revisions of these annexes given the tiny fractional distinction in the analysis contained therein. However, the attached charts indicate for each duplicate any of the annexes which double counted what we now believe to be a single individual and the difference this made to the analysis in those annexes.
