Questions and answers:

Q. In total, how many prisoners were detained in Ou Kanseng Re-Education Centre (មន្ទីរអប់រំ កែស្រែអូកន្សែង)?

A. The centre was established in late 1976 and about 40 prisoners were detained there. The number of prisoners was increased to about 70 in 1977 which was known as the screening period. In 1978, there were about 100 prisoners as more prisoners from the cooperatives and workers from trade unions were sent to the centre. Therefore, the total prisoners [detained] in this re-education centre did not amount to thousands due to a small number of the security guards. There were only 12 people, including the centre cadres. It seemed that the re-education centre belonged to the zone security centre but it, in fact, was Division 801 centre.
