I, JUDGE KONG SRIM, President of the Supreme Court Chamber of the Extraordinary Chambers in the Courts of Cambodia for the Prosecution of Crimes Committed during the Period of Democratic Kampuchea between 17 April 1975 and 6 January 1979, which is seized of the "KHIEU Samphân's Urgent Appeal against the Judgement Pronounced on 16 November 2018", filed on 19 November 2018 ("Appeal").

NOTING the letter of resignation of Judge Agnieszka KLONOWIECKA-MILART, and Internal Rule 79(4),² according to which the President of the Supreme Court Chamber may designate **Reserve Judge** to sit in place of absent judge for the remainder of the proceedings in question;

CONSIDERING that, in light of the issues raised in the urgent appeal warranting a decision by full panel and issued in timely manner, it is required that **Reserve Judge** be appointed to sit in place of absent judge for the matters pending before the Chamber;

HEREBY APPOINT:

Judge Phillip RAPOZA as a judge to sit in the panel for the matters pending before the Supreme Court Chamber.
