I. SUBMISSION

- On 27 May 2020, the Co-Prosecutors were notified of the Civil Party Lead Co-Lawyers' requests¹ concerning Khieu Samphan's non-compliance with Article 6 of the Practice Direction on Filing of Documents,² when he filed his appeal brief and accompanying table of authorities³ in relation to the Trial Judgment.⁴
