KAING Guek Eav, alias **Duch**, Male, Born on 17 November 1942;

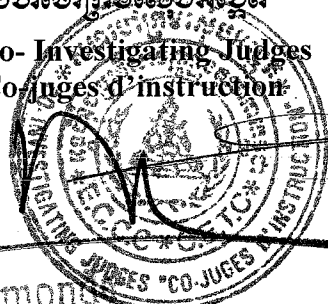




