The Victims Unit in its capacity as the central contact point between the ECCC and victims and their legal representatives, has received three Power of Attorney letters from Mr. Bou Meng, Mr. Chum Mey and Mrs. Chhin Navy who are Civil Parties in Case File No. 001/18-07-2007-ECCC-OCIJ (Bou Meng, Chum Mey, Chhin Navy) and Case File No. 002/19-09-2007-ECCC-OCIJ (Chum Mey, Chhin Navy). We hereby forward those letters to your office.

In their letters, Mr. Bou Meng, Mr. Chum Mey and Mrs. Chhin Navy have appointed lawyer Ms. Silke Studzinsky as their international legal representative for all proceedings before the ECCC. Ms. Silke Studzinsky has sent her application requesting her placement on the list of lawyers willing to represent Civil Parties. The Bar Association of the Kingdom of Cambodia has accepted her application and is in the process of designating a date for the swearing in ceremony, which is likely to occur this or next week.
