

The Vicitms Unit has received confirmation from the Bar Association of the Kingdom of Cambodia (BACK) stating that Ms. Silke Studzinsky was duly admitted to be member of the BAKC on 4 October 2007 and has sworn in on 7 March 2008 before the Appeal Court of Cambodia. Consequently, she is entitled to act as a foreign Co-Lawyer before the ECCC.
