During August 76, the Ministry of Commerce made plans for 1977 for machinery, raw materials, and various merchandise for the State and for the livelihood of the people throughout the country.

Each Ministry made plans for its necessary purchase proposals.

The Ministry of Commerce was responsible for examining documents and lists for all proposed purchases, the identification, technical characteristics, size, scale and amount required. It was done in this way to avoid buying items of the wrong size which would be useless and would be a loss for the work and a loss of funds.

One day (cannot remember) I telephoned to Office "S8 MG" (Public Works) at 2:00 in the afternoon and proposed [to meet with] one or two cadres who had the capability grasp the technology and various characteristics of machinery required to be purchased according to Sân's MS proposed list. Along with this, I set 3:00 for my arrival time at the Ministry of Commerce, and I took the documents on that machinery with me.

I told the person on the telephone, "If Brother Phing ភ៌ឹង has a grasp on these matters and if he is free, I request he be there in person."

- 1. On my (Doeun เขียง) plans for treason in sending traitor forces into the Office of Angkar
- 2. The period of internal war from 1969 until 1970

During this period, the Party had Zone 304 select a number of male and female proletarian youth to study politics and technology and then return to disseminate the information in their villages. Then Thuch \mathfrak{P} was busy working with Angkar, so I accepted responsibility for gathering the forces and arranging to send them as designated by the Party. These forces were traitors. Before they traveled, I held a meeting to instruct them to strive in their work and to maintain secrecy, not to allow anything to leak out. Materials for personal use were supplied as Angkar had instructed, such as hammocks, trousers and shirts, kerchiefs. The names of those I sent are recorded below, one after another:
