• This person declared that he/she could read, write, and understand the Khmer (and a little Thai) language. Therefore, the original of this Written Record is written in the Khmer language.

• We advised this person that the taking of this statement is being audio or video

ecorded.

• This person told us that he/she had no relationship with the Charged Persons and Civil Parties.

• This person took an oath in accordance with the provisions of Rule 24 of the Internal Rules of the Extraordinary Chambers.

• We notified this person of the right against self-incrimination, in accordance with the provisions of Rule 28 of the Internal Rules of the Extraordinary Chambers.

Question-Answer:

Q: Where were you from 70 to 75?

A: Living with my parents in Steung Trèng. I was 12 years old then. I had no work, was not doing anything.

Q: Where were you during the three year era?

A: I was at Phnom Chet Ris ភ្នំចិត្តវិស, and later I studied medicine at the 17 April Hospital. I began studying in September 1976, and was at the 17 April Hospital all the way up until I fled the Yuon.

Q: Who supervised 17 April Hospital?

A: It was under the supervision of THIOUNN Thioeunn ជូន ជឿន alias Pèn ប៉ែន. I did not know the cadres above Pèn.

Q: What did you do while you were at the 17 April Hospital?
A: I was in the section cleaning the wounds of soldiers who had been making war at the Vietnamese border. Under Pèn there was Ny \$\vec{8}\$, who was in charge of tuberculosis.

Aside from this, I did not know the names of the team leaders. I heard that Ny had studied medicine in France. In 1975 I was living at Phnom Chet Ris growing vegetables and farming rice with \$\vec{n}\$ Kou.

- One copy of the written statement was provided to this witness.
- After it was read aloud the witness had no objections and agreed to sign or emplace thumbprint.

The interview was completed at 6:30 in the evening on the same date.
