Excerpt of Confession of Heap Sun Huong alias Pheat

[Hereunder is the translation of only the red-ink handwritten annotations appearing in the margins of the document]

[Translation of comment in red in left hand margin and the middle of page 00174764]  
[Huong has] already been taken.

Minute

Respected brother,

1. The first reason for the arrest of A Huong (អង្គឃុំ) was that he always made contacts with the people in the cooperative in the old Stung Mean Chey - those who had been sent to S-21 (from the paddy fields). Our S-21 comrades tried to warn him, but he did not listen to them. He kept making contacts [with them].

I have reported it to Uncle Phon (ផែន). He said Brother Ney (នៃ) had principally instructed that A Huong's activity be strictly monitored. He then decided to send [Huong] to the paddy fields.

2. After he had been sent to the paddy fields, Uncle Phan searched his room and found some hand grenades and other things that belonged to his clique. I brought [him] in for interrogation.
3. Thus, [I managed to get] some confessions on the remaining string of A Sok (A Sok working in the municipality).

1. This confession involves the investigating section of the electricity sector.
2. There are still Sok's strings (his clique) who are ready to take actions against us because hand grenades have been found in his house.
3. The confession led to the arrest of Sok's 3-4 other strings with whom we have not yet had any measures against them yet.
