For the rest, he talked only about the group that has been uncovered. The whole content of the story consistently implicates Bâng Phuong and it is difficult to have any part of the story removed, because if it is removed, then there will no further related story..

> 4/ It is also difficult for me to examine it as I do not know much about the event of that time. As to Bang Phuong, I have some information that he is linked to comrade Yeng, who came from the capital and entered there secretly. If it is as he said, why he did not say it to comrade Yeng.(?)14/10/77
