A. Selected Editorial Members who have worked or are currently working for Chambers or Prosecution at the ICTY

1. **Jia Bing Bing** (Board of Editors) – Legal Assistant to Judge Li Haopei and Judge Wang Tieya, members of the ICTY and ICTR Appeals Chamber; Associate Legal Officer, Appeals Chamber, ICTY and ICTR.¹
2. **O-Gon Kwon** (Board of Editors) – Judge at the ICTY since 2001. Sat on the trials of *Prosecutor v. Milošević*² and *Prosecutor v. Popović et al.*,³ both of which concern JCE.
3. **Bert Swart** (Board of Editors) - Assigned as a Pre-Trial Judge in the case of *Prosecutor v. Milutinović*, which concerned JCE.⁴
4. **Salvatore Zappalà** (Managing Editor) – worked at the ICTY in both Chambers and Registry from 1995-97.⁵ Co-author of a book with Professor Cassese.⁶
5. **Guénaél Mettraux** (Editorial Committee) - Associate legal officer to Judge David Hunt who was a member of the ICTY Appeals Chamber which issued a central decision on JCE.⁷
6. **Daryl Mundis** (Editorial Committee) - Senior Trial Attorney in the case of *Prosecutor v. Rasim Delić*.⁸ Also appeared as a prosecutor in the case of *Prosecutor v. Prlić et al.*, where JCE is being charged.⁹
