Description of the alleged criminal act(s)	The applicant described that on 13 August 1978, three foreign men – Mr. Kerry HAMILL (the applicant's brother, from New Zealand), Mr. Stuart GLASS (a Canadian) and Mr. John DEWHIRST (from England) - were in a yacht and anchored at Koh Tang in Sihanouk Ville, when they were fired on by the KR. Stuart GLASS died and was buried at sea. The other two men were shackled, blindfolded and taken to the cinema in Sihanouk Ville before being taken to Tuol Sleng prison (S-21). When they arrived at Tuol Sleng prison (S-21), the two men were subjected to interrogation, tortured, and electrocuted. They were forced to sign confessions and were accused of being CIA agents. There were accounts of two foreign men that they were put into car tires and covered with petrol and set ablaze; Kerry HAMILL and John DEWHIRST presumably were these two men. The victim's death had a massive, devastating impact on the complainant's family.
