Uncle Nuon (១១)

Telegram 67: 380 characters: We would like to inform the Brothers of the following:

On 10 April, we brought the Brothers' letter and instructions to inform the Thai Embassy. They were happy to send the letter and matters we met with them about to their Ministry of Foreign Affairs. In that meeting, the Thai raised the same issue, that our troops together with Thai communists had entered and attacked them. They said that they had reported to their Ministry of Foreign Affairs that there were no Kampuchean troops together with Thai communists, and their Foreign Ministry believed that, but the military side had reported back that it was certain that Kampuchean troops were together with the Thai communists.

We responded that the Thai side had already seen the response of our Ministry of Foreign Affairs: that we are engaged in fighting the Yuon, Kampuchea has no desire to create a dispute with the Thai, and the Yuon are now preparing to attack Kampuchea once again in April.

The allegation that there were Kampuchean troops with the Thai communists is false.

The events that keep occurring at the border are caused by a third force. This force belongs to ញ៉ា Tam (អ៊ិនតាំ), who is currently in Thailand and together with other reactionaries who are C.I.A.

So, our two sides must unite to eradicate them.

They responded that ញ៉ា Tam, according to their Ministry of Foreign Affairs, had left with his family to go to France on 22 [illegible month and year]...? They also stated that they were waiting for a request from Kampuchea to solve Thai-Cambodian border issues quickly. They pressured us to return the people and property that they say are now in our territory.
