### Summary of Proceedings:

Oral arguments concerning the Chamber's provisional list of witnesses, Civil Parties and experts

The Chamber gave the parties an opportunity to comment, including in relation to objections, if any, to its previously circulated tentative lists of witnesses, civil parties and experts for the first phases of the trial. All parties made comments on the tentative lists. In particular, the Accused KHIEU Samphan addressed the court in person. Due to the

current confidential nature of the lists, a portion of the hearing was held in closed session. Technical problems were experienced during the closed session that required the hearing to continue into the afternoon.

leng Sary Defence's request for leng Sary to follow proceedings from the holding cell The Defence for Ieng Sary requested leave for the Accused to follow the proceedings from the holding cell due to back problems. The Chamber granted the request.

### **Requests to Address other Matters**

Defence Ieng Sary requested to address other matters which it deems being of a jurisdictional nature before the end of today's hearing: applicability of international law, applicability of command responsibility, and applicability of crimes against humanity. Defence Nuon Chea and Civil Party Lawyers requested clarification on whether another Initial Hearing is to be held to address the remaining proposed witnesses, experts and civil parties other than those in the tentative lists.

### Oral Orders/Decisions:

Order granting leng Sary Defence request to authorize the Accused to follow the proceedings from the holding cell and instructing the AV unit to connect the AV link to the holding cell.

Order to bring the Accused back to detention facility.
