Summary of Proceedings

Examination of Accused NUON Chea

The Chamber resumed examination of Accused NUON Chea.

Request for re-evaluation of medical condition

The NUON Chea Defence requested medical examination of the Accused. The Chamber granted the request and ordered medical examination of all Accused during the recess.

Request to adjourn examination of NUON Chea

The NUON Chea Defence requested to adjourn the examination of the Accused due to fatigue. The Chamber granted the request.

Examination of Accused IENG Sary

The Chamber examined Accused IENG Sary on his identity and personal background.

Observations on examination of IENG Sary

The IENG Sary Defence requested leave to read a statement. The Chamber requested clarification on whether IENG Sary will comment on the charges in the Closing Order. The Defence indicated the Accused's intention to exercise his right to remain silent.

Examination of Accused KHIEU Samphan

The Chamber examined Accused KHIEU Samphan on his identity and personal background.

Observations on examination of KHIEU Samphan

The Chamber requested clarification on whether KHIEU Samphan will answer questions put to him. KHIEU Samphan indicated that he would only comment on the Closing Order, but reserves the right to respond to the Co-Prosecutors' evidence as it is presented.

Response to Closing Order

KHIEU Samphan responded to various paragraphs of the Closing Order read in Court on December 5, 2011.

Request for IENG Sary to observe proceedings remotely from holding cell

The IENG Sary Defence requested that the Accused be allowed to observe the proceedings remotely from the holding cell. The Chamber granted the request. Upon order by the Chamber, the Defence submitted a signed waiver. The Chamber instructed the Greffier to enter the waiver and medical reports of all Accused into the case file. All these documents are attached to this written record.
