#### **Summary of Proceedings**

#### Request to clarify his position

The KHIEU Samphan Defence team asks permission for KHIEU Samphan to clarify his position on whether he will respond to questions put in relation to the second segment of the trial of Case 002. The Accused KHIEU Samphan states that his position of 13 December 2011 has not changed, as he will answer every question concerning the facts raised by parties and concerning fully provided documents.

#### Submissions regarding general evidentiary issues

The Co-Prosecutor, the Co-Lawyers for the Civil Parties, the NUON Chea Defence, the IENG Sary Defence and the KHIEU Samphan Defence make submissions in relation to general evidentiary issues, for instance on issues of authenticity and admission of new documents.

The NUON Chea Defence clarifies that NUON Chea did not exercise his right to remain silent during last week's session but instead challenged the authenticity of the documents presented to him.

The Chamber reads out Rule 87, reminding the Parties of its exact content.

#### Request to follow the proceedings from the detention facility

E1/27

The NUON Chea Defence requests permission for the Accused NUON Chea to follow the proceedings from the detention facility until the end of this week's hearings.

The Chamber requires the Defence to produce a detailed waiver of the Accused's right to be present in the courtroom.

The Co-Prosecutor objects to NUON Chea's request to follow the proceedings from the detention facility, instead of the holding cell. The Chamber rejects NUON Chea's request, as he is required to follow the proceedings via audio-visual means from his holding cell.

#### Request to follow the proceedings from the holding cell

The IENG Sary Defence requests permission for the Accused IENG Sary to follow the proceedings from the holding cell until the end of this week's hearings.

The Chamber grants IENG Sary's requests and requires the Defence team to produce a detailed waiver of the Accused's right to be present in the courtroom.

#### Hearing of oral objections to E3-Documents

The Defence divides the total allocated time of 2 hours among themselves.

The Chamber allows the NUON Chea Defence team to mention names of two DC-CAM witnesses during their statements.

The NUON Chea, IENG Sary and KHIEU Samphan Defence teams present their arguments.

#### Oral Orders/Decisions:

- Order to bring the Accused NUON Chea and IENG Sary to the holding cell.
- Order to bring the Accused to the detention facility and for tomorrow's hearing to bring the Accused KHIEU Samphan to the courtroom and to bring the Accused NUON Chea and IENG Sary to the holding cell.

#### Orders for Adjournment of Hearing

The hearing will resume on Tuesday 17 January 2012 at 9:00am.
