## **Summary of Proceedings**

## Hearing of oral objections to categories of documents contained in Annex A4 (cont'd)

The Co-Prosecutor continues the response to the Defence teams' objections to the documents contained in Annex A4.

The Co-Lawyers for the Civil Parties present their position.

## Enquiry of the estimated time for questioning of witnesses TCW-766 and TCW-542

The Chamber enquires on the estimation of time needed by the parties for questioning witnesses TCW-766 and TCW-542. The Co-Prosecutor estimates that a half day for each. CLCP estimate two hours for each. All three defences (via NC Defence) request a total of

1.5 days. NC needs ½ day for TCW-542. The IENG Sary Defence estimates 1.5 hours for TCW-542. The KHIEU Samphan Defence estimates 15 minutes to 1 hour for TCW-542. The Co-Prosecutor states that it will be able to provide by Tuesday a new list specifying those documents that originate from DC Cam.

#### Hearing of oral objections to categories of documents contained in Annex A5

The NUON Chea, IENG Sary and KHIEU Samphan Defence present their objections in relation to the documents contained in Annex A5.

The Co-Prosecutor continues the response to the Defence teams' objections to the documents contained in Annex A5.

The Co-Lawyers for the Civil Parties present their position.

#### Reply in relation to all objections relevant to Annex A1-A5

As specified in E159, the three Defence teams exercise their right to reply in relation to all objections relevant to Annex A1-A5.

# Request for clarification from the parties of the estimated time needed to examine the Accused NUON Chea

The Chamber requests the parties to provide an estimate of the time needed to question NUON Chea in relation to the first segment of the trial of Case 002.

The Co-Lawyers for the Civil Parties estimate that 4 hours will suffice. The NUON Chea Defence will not need more than one day (i.e. two half days). The IENG Sary Defence clarifies that it has not yet decided whether it will put any questions to NUON Chea; in any case it will not need more than one hour. The KHIEU Samphan Defence will need 45 minutes to one hour to examine NUON Chea.

The Senior Legal Officer will inform the parties on the schedule of next week's hearings.

#### Request for Chamber's decision on Prime Minister's press statements

The Chamber considers this a repetitive matter before the Chamber and directs counsel for NUON Chea not to raise the issue again.

#### Oral Orders/Decisions:

• Order to bring the three Accused to the detention facility and to return the three Accused to the courtroom for the hearing on 23 January 2012.
