Summary of Proceedings

Scheduling of Tomorrow's hearing

The Trial Chamber announces the schedule for tomorrow's hearings, indicating that witness CHANG Youk, the director of DC-Cam, will be heard. One day will be allocated for both the Office of the Co-Prosecutors and the Civil Party Lead Co-Lawyers for questioning of the witness, while the three Defence team will be allocated two days.

Questioning of the Accused NUON Chea (Cont.)

The Civil-Party Co-Lawyers questions the accused NUON Chea. The IENG Sary Defence and the KHIEU Samphan Defence indicates that they do not have any question for NUON Chea. Subsequently, NUON Chea defence questions the accused NUON Chea.

The Accused waives his right to be present in the courtroom for the whole day.
