Comrade Tal:

- 1. There are still no unusual problems as regrds the enemy situation within the unit of organization. But on the west bank in Neak Loeung (នាក់ល្បីង) on 12 September, a person looked around furtively and stole a haversack of rice. The brothers seized and detained him. Later that night, he asked to relieve himself, and while he was being accompanied he ran off and jumped into the Mekong River. The brothers shot him dead and did not get to interrogate him about anything.
- 2. Late in July September, a combatant named BĬN Soeun (ប៊ីន ហ៊ៀន) fled to Kanhchriech (កំព្រៀប) district and hid out quietly in the home of a woman whose husband had been arrested by Angkar. He has been brought back now from the base.
- 3. A company cadre named Chum (ង្វី) went out free as a bird for three or four days, wandering around without permission all the way to Peam Chor (ពាមជរ) district. This guy used to have contact with Chakrei (ចិក្តី).

Comment of Brother 89:

-Would like to tell about the situation in Sector 24 so that the Comrades could maintain mastery in the supervision of Division 290. After Chakrei was arrested, his replies implicated a number of people of Sector 24 who had been in contact with Viet Nam and the Soviets to attack our revolution this 30 September 1976. Now we have arrested Chhouk (Aun), the Secretary of Sector 24 and his cronies. These guys have already confessed that Chakrei's replies were indeed correct.

S-21 and Division 290 had already met and decided on the proposed names, except for the 11 persons decided on in the meeting back on 15 September.

- 1. Based on the reasoning made by S-21 and the Division, which have seen concrete and continuous activities, and based on the principle stipulated by Angkar that Chakrei's links must be taken, the meeting agreed to decide to take these 29 more.
- 2-Decided to take out two more women include Chakrey's wife and niece.

Operational Method

- 1. It is imperative to act in accordance with our experiences in having previously taken these guys again and again. Do it so as to not cause disruption in the unit of organization: grasp the unit of organization firmly in hand and do well in maintaining secrecy. Concretely, consult and discuss with S-21 as regards operational methods for taking them and making assignments to administer the unit of organization while these guys are being removed.
- 2. The Division must have men in hand and have a solid grip on warehouse and weapons in order to be on guard against the enemy seizing weapons from us.

Concrete Methods

- 1. <u>Division 290:</u> S-21 and the Division must cooperate to arrest them from their place and put them in the car immediately.
- <u>2.</u> <u>Division 170:</u> S-21 and the Division must consult with about the details of the concrete measures to take all 40.

As for the two women, think that over together later.

The meeting ended at 2215 hours.
