REQUEST

1. In the course of a document presentation to the Trial Chamber on 10 October 2012 Prosecutor Lysak presented Document E3/1173.¹ He notified the Trial Chamber that the original document consisted of 3 pages, but he was only in possession of pages 1 and 3 as page 2 was missing. He suggested that further enquiries could be made by the Co-Prosecutors or the Trial Chamber in order to clarify the position.
2. On the same day the Co-Prosecutors were contacted by email by the Senior Legal Officer of the Trial Chamber (SLO) who confirmed that the Records and Archive Unit had never been provided with page 2 of the document. The SLO transmitted the Trial Chamber President's request that contact be made with the Document Centre of Cambodia (DC-Cam) to ascertain if the missing page could be located. The Co-Prosecutors immediately contacted DC-Cam who have now confirmed that they received their copy of this document from Professor Ben Kiernan and that it consisted of only pages 1 and 3.
3. Given the importance of Document E3/1173 the Co-Prosecutors request that Professor Kiernan be contacted and he be asked to provide page 2 if it is in his possession. The Co-Prosecutors offer to contact Professor Kiernan if this is deemed appropriate by the Trial Chamber.
