Summary of Proceedings

Waiver of the Accused's right to be present in the courtroom

The accused IENG Sary waived his right to be directly present in the courtroom for the Civil Parties TCCP-82 and TCCP-105. (9:26 and 15:12)

The Accused NUON Chea waived his right to be present in the courtroom for the whole day due to his health condition (10:44). The Doctor to examine NUON Chea during the recess, and the Chamber authorized NUON Chea to follow the proceedings from the holding cell based on the treating doctor's medical report.

Absence of the International Co-Lawyer for IENG SARY

Mr. Karnavas, International Co-Lawyer for IENG Sary is absent today due to personal commitments.

Testimony of Civil Party MEAS Saran (TCCP-82)

The Civil Party lawyers put questions to the Civil Party, followed by the Co-Prosecutors, the Trial Chamber, and the NUON Chea Defence. The IENG Sary and KHIEU Samphan Defence teams stated they did not have any questions to put to the Civil Party.

Expression of suffering of Civil Party MEAS Saran (TCCP-82)

The Civil Party made a general statement regarding the harm he suffered during the DK period.

Ruling on Co-Prosecutors objection

The International Prosecutor asked NUON Chea counsel Mr. Ianuzzi, to put open questions rather than any suggestive questions. The Chamber stated that civil law tradition applied here andquestions that are leading in nature are prohibited. The Chamber added that questions that are posed by parties in which parties are making their own conclusion or speculation and soliciting such consistent responses from the civil parties or witnesses are banned and they are not allowed, indeed, in the civil law tradition and we also are guided by the agreement - by the agreement and also the Internal Rules so that the application of the laws are consistent with what already stated in such rules and agreement.

Testimony of Civil Party Ms. OR RY (TCCP-105)

The Trial Chamber started questioning the Civil Party, followed by the Civil Parties Lawyers.
