Procedural History and Request

- 1. On 17 September 2012, pursuant to rule 87(4) of the ECCC Internal Rules, the Co-Prosecutors sought leave to place on the Case File an audio recording of a lecture ("Lecture") given by expert witness Philip Short on 9 March 2005 at the Centre for South East Asian Studies of the University of California, Los Angeles ("Request"). The Co-Prosecutors also sought leave to play brief excerpts of a video recording of the Lecture, which was at the time only available on-line, during the Expert's testimony. On 18 January, 2013, the Chamber granted the Request.
- 2. Following the filing of the Request, the Co-Prosecutors were able to obtain a copy of the video recording of the Lecture. In accordance with the Chamber's decision on the Request, the Co-Prosecutors respectfully seek leave to place the video recording on the Case File. Given that the Chamber has already permitted the use of this recording during the examination of the expert witness, the Co-Prosecutors submit that it would be in the interests of justice to place the video recording on the Case File. This would allow all parties an equal opportunity to use the recording (both prior to and during the examination) and create a more complete record of Mr Short's evidence on the Case File. It would also remove the risk of technical difficulties which may arise if the video recording is accessed by the use of remote streaming via the internet during Mr Short's testimony.
