Mr. IENG Sary, through his Co-Lawyers ("the Defence"), pursuant to Rule 21 of the ECCC Internal Rules ("Rules") and Practice Direction 3.14 of the Practice Direction on the Filing of Documents Before the ECCC ("Practice Direction 3.14"), hereby requests the Trial Chamber to reclassify document E238/4, Professor Campbell's 6 November 2012 report of his examination of Mr. IENG Sary, from "strictly confidential" to "public." This Request is made necessary because document E238/4 contains no "strictly confidential" information preventing it from being classified as public:

- 1. Mr. IENG Sary has consented to his medical reports being made public. 1
- 2. The contents of E238/4 have been discussed extensively in open court.²
- 3. Rule 21(1) requires that all Practice Directions be interpreted "so as to ensure legal certainty and transparency of proceedings."
- 4. Practice Direction 3.14 provides that a Chamber seized of a case may reclassify any document on the Case File in the interests of justice.

Reclassifying D238/4 as public would promote transparency and would be in the interests of justice.

WHEREFORE, for all the reasons stated herein, the Defence respectfully requests the Trial Chamber to RECLASSIFY document E238/4 as public.
