ORIGINAL/ORIGINAL ថ្ងៃ ខែ ឆ្នាំ (Date): 22-Mar-2013, 09:38 CMS/CFO: Uch Arun 1. **THE SUPREME COURT CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia for the Prosecution of Crimes Committed during the Period of Democratic Kampuchea between 17 April 1975 and 6 January 1979 ("Supreme Court Chamber") is seized of four immediate appeals filed by IENG Sary on 18 December 2012, 3 January 2013, 8 January 2013, and 5 February 2013, respectively ("Immediate Appeals").<sup>1</sup>

2. On 14 March 2013, IENG Sary passed away in Phnom Penh, Cambodia.<sup>2</sup> The Trial Chamber consequently terminated the proceedings against him pursuant to Article 7(1) of the Code of Criminal Procedure of the Kingdom of Cambodia.<sup>3</sup> In these circumstances, the Supreme Court Chamber no longer has jurisdiction to decide on the Immediate Appeals.

3. For the foregoing reasons, the Supreme Court Chamber **DISMISSES** the Immediate Appeals without deciding on the merits.
