Dear parties,

At the hearing tomorrow morning, the Chamber will announce its oral disposition of both the Accused NUON Chea's fitness to stand trial and severance. Written decisions in both matters will follow thereafter as soon as possible. The Chamber will also then announce the date upon which the hearing of evidence in Case 002 will resume, subject to the availability of essential national staff.

The Chamber further wishes to note that it considers the below advance courtesy copy filed by the Co-Prosecutors, suggesting remaining witnesses to be heard at trial, to be premature and unsolicited. The Annex attached to this motion does not reflect the Chamber's view of witnesses and other individuals to be heard at trial. Accordingly, and in the interests of effective trial management, the other parties are requested not to file responses to this motion and annex. Upon resumption, and in accordance with its practice to date and trial management discretion, the Trial Chamber will communicate individuals to be heard at trial, and their order, in due course.
