Summary of Proceedings

Testimony of KAING Guek Eav

The Co-Prosecutors continue to put questions to KAING Guek Eav.

Request to waive Accused's right to be present in the courtroom and observe the proceedings from the holding cell

The Chamber grants IENG Sary and NUON Chea's requests to waive their right to be present in the courtroom and follow the proceedings from the holding cell via the audiovisual equipment (Accused's waivers are attached to this written record).

Request to limit scope of questioning of KAING Guek Eav to Case 002/01

The Trial Chamber observes and reminds the parties to narrow their questioning of KAING Guek Eav to issues relevant to the trial of Case 002/01. The Co-Prosecutor provides clarification as to the questions that the Prosecution intends to put to the witness.

Objection to testimony outside witness' personal knowledge

The IENG Sary and NUON Chea Defence require clarification as to the sources of KAING Guek Eav's testimony. The Chamber clarifies that it will emphasize the witness' personal knowledge of events and documents at the time of the regime and will evaluate the testimony of this witness when it delivers its verdict taking into account the later examination by all the other parties..

Objection to the method of questioning by the Co-Prosecutors

The IENG Sary Defence objects to the method of questioning by the Co-Prosecutors of the witness KAING Guek Eav, arguing that the Co-Prosecutor is "feeding" the witness information.

Request to adjourn today's hearing

Following the request by the Accused NUON Chea to be excused from the courtroom, the NUON Chea Defence requests that the hearing be adjourned until tomorrow morning (21 March 2012). The Chamber instructs the medical team to examine the Accused NUON Chea and to advise the court on whether NUON Chea can effectively follow the proceedings. The Chamber warns the international co-lawyer PESTMAN that any interference with the independent medical team's examination will have repercussions. The Chamber considers his temporary absence from the courtroom an interference and adjourns the proceedings.
