Summary of Proceedings

Testimony of KAING Guek Eay:

Co-prosecutors continue to question witness KAING Guek Eav.

Counsel for IENG Sary objects to questions regarding CPK Statute because witness is not an expert and the statute refers to a period not relevant for to Case 002/1. Counsel for NUON Chea objects to questions regarding S-21 not relevant to Case 002/01.

The TC rejects the objections by both counsels.

Announcement of motion for Rule 35 investigation and stay of proceedings:

Counsel for NUON Chea announces intention to file a motion for investigation into the political interference with ECCC based on the Co-Investigating Judge Kasper-Ansermet's last Wednesday "Note on Egregious Dysfunctions within the ECCC". The Counsel further request for a stay of proceedings until this investigation is carried out. Counsel for KHIEU Samphan supports this request

OCP responds that this remark is only relevant for cases 003 and 004.

Request for additional time in the questioning of witness KAING Guek Eav:

OCP requests one more day, until Thursday noon, to question KAING Guek Eav for an overall 5 days period. Civil Parties request 3 more hours to question KAING Guek Eav. The TC grants OCP and Civil Parties' requests.
