Summary of Proceedings

NUON Chea's statement concerning Duch's testimony:

NUON Chea rejected Duch's testimony. He invoked his right to remain silent.

Discussion on the accused's right to remain silent:

The parties made submissions on the issue of the accused's right to remain silent.

Questioning of witness SAUT Toeung (TCW617):

The OCP started questioning the witness.

Defence Request under Rule 28 - right against self-incrimination:

Counsel for NUON Chea made two applications under Rule 28(8) and 28(9) and the other parties responded. The Trial Chamber rejected the first request and accepted the second.

Trial Chamber's Oral Decision concerning Right to Remain Silent:

The Chamber issued a decision the right to remain silent (see below)

In camera session on Rule 28(8) and 28(9):

The Chamber held a closed session to discuss the application of the Defence under Rule 28(8) and (9).

Waiver of the Accused's right to be present in the courtroom

The Accused IENG Sary and NUON Chea waived their right to be present in the courtroom.

Oral Orders/Decisions:

• Order to bring the Accused IENG Sary (10:37) and NUON Chea (12:07) to the holding cell (waivers of the Accused are attached to this written record).

• Trial Chamber's Oral Decision concerning Right to Remain Silent (11:14):

The Trial Chamber notes the motions involving IENG Sary and KHIEU Samphan's right to remain silent (E164 and E174). It further notes that NUON Chea, after having made statements allegedly relevant to the first segment of the trial, has also indicated that he might exercise his right to remain silent. Pursuant to Article 35 new (g) of the ECCC Law, an Accused shall not be compelled to testify against himself or to confess guilt. Therefore, an Accused cannot be compelled to answer questions put to him. However, in assessing the guilt or innocence of the Accused in its verdict, the Chamber shall consider all of the evidence that has been put before it and subject to examination, including the testimony of the Accused (and the manner in which he testifies). In this regard, and where the Accused elects to alternate between silence and giving testimony, this may be noted by the Chamber when assessing his credibility. The relevant international jurisprudence indicates that adverse inferences from selective decisions to remain silent may be drawn. In any case the Chamber shall not base a finding of guilt exclusively on an adverse inference drawn from silence.

• Order to bring the three Accused to the detention facility and to return them to the courtroom for the hearing on 19 April 2012.

Orders for Adjournment of Hearing

The hearing will resume on 19 April 2012 at 9:00am.
