I, KONG SRIM, President of the Supreme Court Chamber of the Extraordinary Chambers in the Courts of Cambodia for the Prosecution of Crimes Committed during the Period of Democratic Kampuchea between 17 April 1975 and 6 January 1979 ("Supreme Court Chamber" and "ECCC", respectively),

RECALLING that, on 8 February 2013, the Supreme Court Chamber declared the invalidity of the first severance of Case 002, without prejudice to the Trial Chamber's reassessment of the severance of Case 002;¹

RECALLING FURTHER that, on 8 February 2013, the Supreme Court Chamber declared that, "in the event of a renewed severance of Case 002, [it] considers that the ECCC should explore the establishment of another panel within the Trial Chamber to support the timely adjudication of the remainder of Case 002";2

NOTING that, on 26 April 2013, the Trial Chamber decided to sever Case 002 anew;³ and,

RECALLING that, on 23 July 2013, the Supreme Court Chamber considered that the circumstances surrounding the renewed severance of Case 002 makes it imperative to establish a second panel within the Trial Chamber in order to ensure that Case 002/02 can commence as soon as possible after closing submissions in Case 002/01;⁴

1. **HEREBY INSTRUCT** the Office of the Administration of the ECCC to immediately explore the establishment of a second panel of national and international judges within the Trial Chamber to hear and adjudicate Case 002/02.
