Summary of Proceedings

Waiver of NUON Chea's right to be present in the courtroom

The Accused NUON Chea is still admitted to the Khmer Soviet Friendship hospital and waived his right to be present in the courtroom for the entire day, including during the scheduled hearing today of witness TCW-565. According to the medical report, NUON Chea's health has improved significantly and he is expected to be discharged from the hospital shortly.

IENG Sary's request for authorisation to participate remotely in the proceedings and Waiver of IENG Sary's right to be present in the courtroom

The Accused IENG Sary is present in his holding cell due to his health and will participate remotely for the entire day. The Trial Chamber granted IENG Sary's request to participate remotely to the proceedings from his holding cell for the whole day.

Request of the Co-Prosecutors seeking additional time for the hearing of witness Al ROCKOFF (TCW-565)

IENG Sary's defence team argues that the request of the Co-Prosecutors for additional time for the hearing of witness Al ROCKOFF (TCW-565) was submitted too late and requests the Trial Chamber to stick to the original schedule of the hearing. The Co-Prosecutors state that the request for additional time for the hearing was submitted in a timely fashion. The Trial Chamber will assess the situation as the situation unfolds.

Testimony of Witness Al ROCKOFF (TCW-565)

The Trial Chamber, the Co-Prosecutors and, subsequently, the Lead Co-Lawyers for the civil parties put questions to the Witness.

KHIEU Samphan's request for authorisation to participate remotely in the proceedings Request of the Accused KHIEU Samphan to participate from his holding cell for this afternoon's proceedings due to health reasons (KHIEU Samphan is still recovering from bronchitis). Oral Order of the Trial Chamber allowing KHIEU Samphan to participate remotely in this afternoon's proceedings. Instruction to submit KHIEU Samphan's waiver.

<u>Decision regarding request of Co-Prosecutors for additional time to hear witness Al</u> ROCKOFF (TCW-565)

Trial Chamber grants additional time to both the Co-Prosecutors and the Lead Co-Lawyers for the civil parties to put questions to the witness, until the afternoon recess.
