# Summary of Proceedings

# Waiver of NUON Chea's right to be present in the courtroom

The Accused NUON Chea is still admitted to the Khmer Soviet Friendship hospital and waived his right to be present in the courtroom for the entire day.

IENG Sary's and KHIEU Samphan's request for authorisation to participate remotely to the proceedings and Waiver of IENG Sary's and KHIEU Samphan's right to be present in the courtroom

The Accused IENG Sary and KHIEU Samphan are present in their holding cell due to their health. The Trial Chamber granted IENG Sary's and KHIEU Samphan's request to participate remotely to the proceedings from their holding cell for the whole day.

# Ruling of the Chamber regarding objection of KHIEU Samphan against certain documents proposed by Co-Prosecutors

The ruling can be found under 'Oral Orders/Decisions' of this written record of the proceedings.

#### Health of the Accused NUON Chea

The NUON Chea defence team states that the health of Accused NUON Chea is improving, however, the medical reports show discrepancy. The Trial Chamber indicates that only information from the appointed medical experts will be taken into account in assessing any progress on the health of the Accused.

The Co-Prosecutors continue reading documents into the record regarding the role of the Accused KHIEU Samphan.

## Health of the Accused NUON Chea and court schedule for next week

#### Oral Orders/Decisions:

- Order allowing the Accused IENG Sary and KHIEU Samphan to participate from the holding cell during the entire day (waiver of the Accused is attached to this written record).
- Ruling of the Chamber regarding objection of KHIEU Samphan defence against certain documents proposed by Co-Prosecutors: "The Trial Chamber notes the objection of the KHIEU Samphan Defence that certain documents identified by the Co-Prosecutors should not be put before the Chamber pursuant to the Chamber's earlier decision on the written statements of witnesses who will not appear to testify (E96/7). The Chamber has set forth the legal framework for the consideration of written statements in E96/7 and will consider any such statement in light of these legal considerations. The Chamber notes that all documents which were objected to by the KHIEU Samphan Defence, concern individuals who are now deceased, and the Chamber finds them to be sufficiently relevant and reliable to be put before it. Any probative value to these statements will be evaluated based on all of the circumstances and the legal standards set forth in E96/7. However, the document E190.1.72 consists of an interview by an individual who is due to testify before this Court in the near

future. Therefore, the Co-Prosecutor will be allowed to introduce the document during the testimony of this individual. Any objection to the document can be presented at that juncture."

Security personnel are instructed to have IENG Sary returned to his holding cell by 9 a.m. on Tuesday 5 February 2013.
