- 1. Pursuant to Part V of the Trial Chamber's "Order to File Updated Material in Preparation for Trial in Case 002/02" dated 8 April 2014¹ where the Chamber ordered the Co-Prosecutors and each Defence team to file a joint list of uncontested facts pursuant to Rule 80(3)(e) no later than Friday, 6 June 2014 the Co-Prosecutors notify the Chamber that after consultations with the Defence teams of Nuon Chea and Khieu Samphan no uncontested facts within the scope of Case 002/2 could be agreed at this stage.
